Proposal 2 - Repairs to an existing small sinkhole, which developed in the driveway along Stephens Elementary, after the project was bid. This was a repair to the curb, the blacktop, and the adjacent slope with re-seeding. ADD \$17,496.

Proposal 3 - This change order, which is rather large in nature, is for the existing lot at Burlington Elementary - once the milling and new asphalt operations began, it was determined to be excessively soft underneath and was deforming under even moderate loads. We witnessed this firsthand and found the dirt to be the consistency of peanut butter, for lack of a better descriptor. This cost is for digging out the soft material, installing a filter fabric and stone underneath the new surface to bring it back and permanently fix the issue. ADD \$133,441.

Proposal 4 - This is for removal of an existing fence at Kelly Elementary, which allowed the District to install a new fence under separate contract - this cost is only for the removal of the existing fence as the District was able to purchase the new fence direct to save money. ADD \$2,444.
