-Memorandum of Agreement Terms and Conditions

Revised September 2024

This Memorandum of Agreement (MOA) is entered into, by and between the Commonwealth of Kentucky, KENTUCKY DEPARTMENT OF EDUCATION ("the Commonwealth") and Garrard County Board of Education ("the Contractor") to establish an agreement to provide supplemental educational and barrier reducing services to the district's migrant students with the implementation of the Title I, Part C Migrant Education Program. The initial MOA is effective from OCTOBER 1, 2025 through SEPTEMBER 30, 2026.

Scope of Services:

The goal of the Garrard district is to provide supplemental educational and barrier reducing services to Mercer migrant students with the implementation of the Title I part C program.

Goals/Deliverables:

The following deliverables will serve as leading indicators of progress toward these goals.

- Respond to requests from LEA and SEA in a timely fashion following SEA-established protocol.
- District MEP staff must attend in-state professional development training, regional staff meetings, the annual Migrant Academy and any other state mandated training. The district administrator must attend the annual required administrator training, and any other training recommended by the regional director.
- Provide evidence based educational supplemental instructional services to migrant priority for service students and document such in the instructional plan in the migrant web app.
- Provide Evidence based educational supplemental instructional services to those students that are failing to meet the state standards and document the services in the web app.
- Update migrant needs assessments quarterly in the web app.
- Complete the migrant preschool screeners twice a year for all students P3-P5 not enrolled in preschool and document in the web app.
- Complete monthly preschool lessons for students ages P3-P5 who are not enrolled in preschool and document in the web app.
- Provide monthly contacts to the out-of-school youth and document services in the web app
- Complete the out-of-school-youth profile within two weeks of completing the Certificate of Eligibility (COE)
- Complete the migrant transition ready checklist for students grades 9-12 and document quarterly updates in the web app.

- Each district must employ a part-time and/or full-time advocate to implement and ensure the educational needs of all eligible migrant children. (It is highly recommended to employ bilingual English/Spanish advocates.)
- Quarterly MEP CDIP expenditure reports are submitted timely to KDE finance office and regional director.
- Collaborate with the SKYMEP as they offer the KEYS Academy and assist with summer tutoring. District staff will assist to ensure PFS students receive at least 25 hours of academic instruction in the summer.
- Summer programming must include preschool, elementary-age, and secondary students; and, where applicable, out-of-school youth (OSY). Priority for Service (PFS) students (K-12) MUST receive academic services during the summer either directly from a migrant staff member or as facilitated by migrant staff members.
- Districts must participate in the regional PAC.
- Districts must submit completed verifications to the regional office by the 1st Monday in December for funding purposes.
- Participate in training by the SKYMEP staff as they assist with recruiting twice a month. District staff are responsible for ongoing recruitment.
- Submit monthly detailed MUNIS-EERP Reports for 311M to Betty Perkins. Submit P.O. report upon request.
- Ensure that migrant staff that are partially paid with migrant funds complete an accurate PAR report.

Districts must abide by all federal and state regulations, and program policies and procedures set forth. **KDE reserves the right to change these deliverables in emergencies.

Reporting:

Quarterly MEP CDIP expenditure reports are submitted timely to KDE finance office and regional director.

The Garrard County school district is responsible for ensuring the timely completion of quality deliverables and documentation of services rendered to migrant students and families. As a subgrantee of the Kentucky Department of Education, Garrard is required to submit documentation including but not limited to the deliverables listed below. Deadlines for submission of documentation are noted in items below, although KDE reserves the right to change deadline dates if circumstances warrant.

Data Security and Breach Protocols

The contractor hereby agrees to cooperate with the Commonwealth in complying with the response, mitigation, correction, investigation, and notification requirements of the Act.

The contractor shall notify as soon as possible, but not to exceed seventy-two (72) hours, the contracting agency, the Commissioner of the Kentucky State Police, the Auditor of Public Accounts, the Kentucky Attorney General, and the Commonwealth Office of Technology of a determination of or knowledge of a breach, unless the exception set forth in KRS 61.932(2)(b)2 applies and the contractor abides by the requirements set forth in that exception. in the same manner as above. Notification shall be in writing on a form developed by the Commonwealth Office of Technology.

The contractor hereby agrees to report, immediately and within twenty-four (24) hours, any known reasonably believed instances of missing data, data that has been inappropriately shared, or data taken off site to my immediate supervisor, Associate Commissioner, and to the KDE Office for whom I perform work under the contract with KDE.

The contractor hereby agrees that the Commonwealth may withhold payment(s) owed to the contractor for any violation of the Identity Theft Prevention Reporting Requirements.

The contractor hereby agrees to undertake a prompt and reasonable investigation of any breach as required by KRS 61.933.

Upon conclusion of an investigation of a security breach of Personal Information as required by KRS 61.933, the contractor hereby agrees to an apportionment of the costs of the notification, investigation, and mitigation of the security breach.

In accordance with KRS 61.932(2)(a) the contractor shall implement, maintain, and update security and breach investigation procedures that are appropriate to the nature of the information disclosed, that are at least as stringent as the security and breach investigation procedures and practices established by the Commonwealth Office of Technology:

Memorandum of Agreement Standard Terms and Conditions Revised August 2025

1.00 Effective Date

All Memorandum of Agreements are not effective until the Secretary of the Finance and Administration Cabinet or his authorized designee has approved the agreement and until the agreement has been submitted to the government contract review committee. However, in accordance with KRS 45A.700, memoranda of agreement in aggregate amounts of \$50,000 or less are exempt from review by the committee and need only be filed with the committee within 30 days of their effective date for informational purposes.

KRS 45A.695(7) provides that payments on personal service contracts and memoranda of agreement shall not be authorized for services rendered after government contract review committee disapproval, unless the decision of the committee is overridden by the Secretary of the Finance and Administration Cabinet or agency head if the agency has been granted delegation authority by the Secretary.

The Commonwealth will make payment within thirty (30) working days of receipt of contractor's invoice or of acceptance of goods and/or services in accordance with KRS 45.453 and KRS 45.454.

Payments are predicated upon successful completion and acceptance of the described work, services, supplies, or commodities, and delivery of the required documentation. Invoices for payment shall be submitted to the agency contact person or his representative.

2.00 Cancellation Clause

Both parties shall have the right to terminate and cancel this contract at any time not to exceed thirty (30) days' written notice served on the Contractor by registered or certified mail.

3.00 Funding Out Provision

The state agency may terminate this agreement if funds are not appropriated to the contracting agency or are not otherwise available for the purpose of making payments without incurring any obligation for payment after the date of termination, regardless of the terms of the agreement. The state agency shall provide the Contractor thirty (30) calendar day's written notice of termination of the agreement due to lack of available funding.

4.00 Reduction in Contract Worker Hours

The Kentucky General Assembly may allow for a reduction in contract worker hours in conjunction with a budget balancing measure for some professional and non-professional service contracts.

If under such authority the agency is required by Executive Order or otherwise to reduce contract hours, the agreement will be reduced by the amount specified in that document. If the contract funding is reduced, then the scope of work related to the contract may also be reduced commensurate with the reduction in funding. This reduction of the scope shall be agreeable to both parties and shall not be considered a breach of contract.

5.00 Access to Records

The state agency certifies that it is in compliance with the provisions of KRS 45A.150, "Access to contractor's books, documents, papers, records, or other evidence directly pertinent to the contract." 6.00 Violation of tax and employment laws

KRS 45A.485 requires the Contractor and all subcontractors performing work under the contract to reveal to the Commonwealth any final determination of a violation by the Contractor within the previous five (5) year period of the provisions of KRS chapters 136, 139, 141, 337, 338, 341, and 342. These statutes relate to corporate and utility tax, sales and use tax, income tax, wages and hours laws, occupational safety and health laws, unemployment insurance laws, and workers compensation insurance laws, respectively. Disclosure of any violations is required prior to the award of any state contract and throughout the duration the contract.

Failure to disclose violations, shall be grounds for the Commonwealth's disqualification of a contractor or subcontractor from eligibility for future state contracts for a period of two (2) years.

To comply with KRS 45A.485, the Contractor and all subcontractors performing work under this contract shall report any such final determination(s) of any violation(s) within the previous five (5) years to the Commonwealth by providing a list of the following information regarding any violation(s): (1) specific KRS violated, (2) date of any final determination of a violation, and (3) state agency which issued the final determination.

A list of any disclosures made prior to award of a contract shall be attached to the contract. The Contractor affirms that it has not violated any of the provisions of the above statutes within the previous five (5) year period, aside from violations explicitly disclosed and attached to this contract. Contractor further affirms that it will (1) communicate the above KRS 45A.485 disclosure requirements to any subcontractors and (2) disclose any subcontractor violations it becomes aware of to the Commonwealth.
