## **Position Summary:**

The Music Performance Coordinator supports the elementary school's fine arts program by planning and leading student musical performances. This role provides students with opportunities to develop their musical skills, showcase their talents, and engage families and the school community through the arts.

- Certified elementary teacher or staff member with experience in music instruction preferred.
- Strong organizational and leadership skills.
- Ability to collaborate with staff, students, and families.
- Commitment to promoting student growth and positive performance experiences.

## Commitment and Responsibilities:

- Coordinate, plan, and direct at least two student musical performances each school year.
- Organize and prepare vocal and/or instrumental groups for performances.
- Collaborate with school staff to schedule events and secure necessary resources.
- Provide students with opportunities to rehearse and refine musical skills.
- Promote family and community engagement through student performances.
- Dedicate time outside of the regular school day for rehearsals and events as needed.
