### **Board of Control Meeting to Convene**

# General Counsel Review of Procedures and Protocols for a Remote Meeting and a Special Meeting

Association and Board Counsel Chad Collins reviewed procedures and requirements around KRS 61.826(1) which applied to this meeting. There was no action on this item,

#### Adoption of final wording of Bylaw 6 Proposal for Annual Membership Meeting.

The Board considered and determined which proposal(s) regarding amendments to Bylaw 6 would be presented to the membership at the September 18th meeting. Three options were reviewed, which could be further amended during the meeting, for final reading approval and distribution for the Annual Meeting.

In August, the Board approved Option 1 on the attached document to be submitted to the membership with the staff to finalize wording before submission to the schools. In traveling the state and discussing the proposal, the thought of Option 1 as the sole choice did not find favor with a good deal of the membership as an open opportunity. However, there was frequent discussion about liking the concept if guard rails were further attached.

The key opposition that has been shared to any change in the transfer rule is an option to transfer during the season without meeting one of the enumerated exceptions. When the concept of a minimum percentage of participation was discussed at prior board meetings, there was not

consensus on its best interpretation. After significant feedback, Options 2 and 3 were alternatives for final consideration.

Option 2 would allow a 10th grader who had not played in 20% of the regular season limit during the 9th grade year to be able to have the period of ineligibility waived as long as it was prior to the 10th grade season starting.

Option 3 would further allow students at any grade the same option. The one issue to be clarified is the defined period in the subsequent year, and determining if it should be before first game, or before first practice. It is done differently in different states that have adopted something similar.

Commissioner Tackett presented to the Board three (3) options for amending Bylaw 6-Transfer. This proposal will be presented at the KHSAA Annual Meeting of Schools on September 18, 2025. After discussing the options, there was a motion by Greg Howard and a second by Terry Yeast to remove Option 1 of the proposal.

#### **Motion Withdrawn**
