## SCHOOL CHANGES NECESSITATING ADJUSTMENTS

- 2008-2009
- Randall Cooper High School opens in NKY, placed in 9<sup>th</sup> Region, 33<sup>rd</sup> District
- St. Henry moved from 33<sup>rd</sup> District to 34<sup>th</sup> District due to Cooper moving in
  
- 2010-2011
- Collins High School opens, placed in 8<sup>th</sup> Region, 30<sup>th</sup> district with Shelby
- Eminence moved to 8<sup>th</sup> Region, District 31
  
- 2019-2020
- Great Crossing High School opens, placed in the 11<sup>th</sup> region, 41<sup>st</sup> District
- Frankfort Christian exits probationary status, placed in 11<sup>th</sup> region, 41<sup>st</sup> District
- Combined moves necessitated moving 11<sup>th</sup> region geographically extreme school Woodford County into 30<sup>th</sup> District (closest non-11<sup>th</sup> region district)
  
- 2020-2021
- Trimble County requests to move from 8<sup>th</sup> Region, 29<sup>th</sup> District to the 31<sup>st</sup> District, moving from 4 teams to 6 teams, leaving 3 teams and 6 teams in the districts
- All 9 impacted schools in those two districts signed agreement to the proposal.
