1. Pricing:

- Itemized pricing for each supply, piece of equipment, or tool listed in the attached document.
- Cost of delivery (if applicable).
- Any applicable taxes, fees, or additional charges.

2. Timeline:

- Estimated lead time for delivery or pickup.
- Any constraints regarding availability of items.

3. Warranty:

- Warranty coverage for tools and equipment, where applicable.

4. Terms and Conditions:

- Payment terms.
- Return policies or conditions for defective items.
