Budget/Financial Issues:

No expense to the Floyd County Board of Education, as fundraising will be done by the Honor's Club and through donations to cover the cost of the trip.

Background and Rationale:

South Floyd Elementary School is requesting the opportunity to take honor students from South Floyd Elementary, grades 6th through 8th, on a trip to Florida. Requirements for honor students include: Minimum GPA of 3.0, 94% attendance, and no major office referrals. The purpose of this trip is to give students something to work toward this year and allow students the opportunity to see other places outside of Kentucky. Members of the South Floyd Elementary Honors Club will travel, by charter bus, to Florida. This event will take place during Spring Break, March 28-April 2. While in Florida students will get to visit Universal Studios and Daytona Beach. For many of our students, this will be their first time visiting a theme park or getting to experience seeing the ocean for the first time. This trip will expose students to things that they can not find in Kentucky, like the ocean.
