National PTA's dues increase of 1 (one) dollar goes into effect on July 1<sup>st</sup>. Kentucky PTA is proposing a state dues increase (to be voted on at convention) that, if passed, would go into effect on August 1<sup>st</sup>.

Because of that, Kentucky PTA is allowing each PTA/PTSA to increase their dues by no more than 2 (two) dollars by filling out this form. - *If the dues increase does not pass for Kentucky PTA, then you would only be eligible to do a 1-dollar increase to cover nationals' portion, and KY PTA will automatically adjust your membership dues price approved on this form accordingly.* - This will stay in effect until you have a chance to update your bylaws. This is only approved as an amendment to your current approved bylaws- nothing else changes. If you choose to start the bylaws renewal process now, you can find the fillable bylaws form online at [www.kypta.org](http://www.kypta.org). Please remember you must give 30 days' notice to your general membership before renewing the bylaws.
