L. Call to Order

Chairman Joe Ray Thornbury called the meeting to order and began with a moment of silence afterward, leading attendees in the Pledge of Allegiance.

Principal Glenda Adkins shared with a brief recap of activities of both academic and athletic achievements and what is happening to plan for the upcoming school year.

Principal Brandon Blackburn shared with a brief recap of activities of both academic and athletic achievements and what is happening to plan for the upcoming school year.

D. District Administrator Reports

Mrs. Denise Clark, CFO reported that the school year is off to a good start. She expressed gratitude for the new food service team and acknowledged that, although there have been a few setbacks due to personal losses, the staff has worked together with patience and resilience. She noted appreciation for the support of Officer Paul, who obtained his food handler's card and stepped in to assist when needed. Mrs. Clark emphasized her thankfulness for the patience and support shown as the department reorganizes, and she highlighted that positive progress is being made. She concluded by affirming the commitment to continue building the program and providing what is needed to serve students and staff successfully at both school buildings.

Mrs. Jeri McNamee, Assistant Food Service Director, provided an update and presentation on current and upcoming food service initiatives. She shared information about the Fresh Fruit and Vegetable Program (FFVP) Grant, explaining its goals and plans to incorporate local farmers by providing samples during Family Night. The primary objective of the program is to increase children's consumption of fruits and vegetables. Ms. McNamee also discussed the implementation of new breakfast procedures across the district and the introduction of additional lunch options at Pikeville High School. In recognition of National School Lunch Week, scheduled for October 13th through 16th, Pikeville High School will host a "Taste Around the World" event, giving students the opportunity to try foods from different cultures. Additionally, she introduced Mosaic, a new food service software designed to assist with recipes, menu planning, and inventory management, which is expected to increase both efficiency and accuracy in daily operations.
