The Henderson Co. Student Nutrition Dept. would like to request the Board to declare the serving lines at Cairo Elementary (Manufacturer - Southern Equipment, Serial No. 82081-20, Model No200-HFW 390, see attached, No asset tag available) to be declared surplus property so they can be disposed of. KDE has approved a request for emergency purchase for new serving lines due to the serious nature of numerous problems existing with Cairo's current serving lines. The Vendor providing the new serving lines is willing to remove the existing serving lines, with the help of our Maintenance team, and dispose of them free of charge. These serving lines are approximately 20-25 years old and maintenance is no longer able to find replacement parts for the units. The serving lines are considered unrepairable and not suited for surplus sale.

The Henderson Co. Student Nutrition Dept. would like to request the Board to declare the 3 section, 12 Door Pass-Thru Cooler at Cairo Elementary (Manufacturer - Hobart, Serial No. 32 542 866 KM, Model No: Q3, see attached photo, No asset tag available) to be declared surplus property so it can be disposed of. This unit has been repaired numerous times by Mr. Hensley and is no longer repairable. Our specification for the new refrigeration unit requests the vendor remove the existing unit, with the help of our Maintenance team, and dispose of it free of charge. This unit is estimated to be between 35-40 years old and replacement parts are no longer available for this unit. The refrigerator is considered unrepairable and not suited for surplus sale.
