Maryville Elementary School's Family Resource Center is requesting approval for Area 502 Mixed Martial Arts MOA. Area 502 will be facilitating this after-school fitness and character development program called Patriot Strong. In addition to fitness, objectives are bully prevention, respect, and positive coping skills. Each 6 week session will be one hour, right after school, twice a week for students referred by the Guidance Counselor and the Principal. Parent/Guardian registration is required. Funding will be paid through the Family Resource Center grant.

Attached is the updated MOA that has been reviewed and approved by BCPS legal counsel- Dinsmore & Shohl. The program is set to begin as soon as possible once approved by BCPS's Board of Education.

## **MEMORANDUM OF AGREEMENT (MOA)**

**Between**

**Area 502 Mixed Martial Arts and Maryville & Overdale Family Resource Center**

### **1. Purpose**

This Memorandum of Agreement (MOA) outlines the terms and conditions under which **Area 502 Mixed Martial Arts** will provide after-school fitness and martial arts classes for the **Maryville & Overdale Family Resource Center**. The program focuses on fitness, bully prevention (emphasizing respect for others and adults), and confidence building.

### **2. Program Details**

- **Group Name:** Patriot Strong
- **Duration :** 1hr Twice a week for 6 weeks.
- **Proposed starting date :** 3:45pm (Tuesdays and Thursdays)
- **Target Group :** Students Elementary School
- **Program Focus:**

**1. Physical Fitness 2. Bully  
Prevention 3. Confidence  
Building 4. Life Skills  
Development**

### **3. Student Conduct Policy**

To maintain a safe and productive learning environment, students are expected to:

- Follow all instructions provided by the coaches.
- Demonstrate respect for coaches, peers, and themselves.
- Behave in a manner that supports a positive and inclusive atmosphere. **If a**

**student fails to follow the coach's rules or displays inappropriate behavior that disrupts the class**, the issue will be discussed with the **Maryville Patriot Strong** staff and, if necessary, with the student's parents/guardians. The coach reserves the right to request that the student no longer attend classes if the behavior continues or is deemed unacceptable.

#### **4. Fee Structure**

The following fee schedule applies based on the number of students per

session: **Number of Students Cost Per Session (each session being 12 lessons over 6 weeks)**

1–5 Students \$100/session

6–15 Students \$150/session

16–25 Students \$200/session

- Payments are to be made in advance for the entire program or as otherwise agreed upon.

#### **5. Class Cancellations**

If, for any reason, a scheduled class is canceled by **Area 502 Mixed Martial Arts** (e.g., coach unavailability, inclement weather, or unforeseen circumstances), a **make-up date** will be provided to ensure the total number of contracted classes is fulfilled.

## **6. Roles and Responsibilities**

### **Area 502 Mixed Martial Arts will:**

- Provide experienced and qualified instructors.
- Deliver engaging, structured classes twice a week.
- Focus on fitness, bully prevention, confidence-building, and life skills development in a safe environment.
- Provide background checks for all employees interacting with students.
- Bear all responsibility for the actions related to this Agreement.  
In addition, 502 Mixed Martial Arts agrees to obtain comprehensive liability insurance coverage in case of bodily injury, personal injury, property damage, contractual liability, and cross-liability. There shall be a minimum amount of combined single limit of \$1,000,000.00.
- Indemnify and hold Bullitt County Public Schools harmless from any loss or liability from performing the services under this Agreement.

### **●Maryville & Overdale Family Resource Center will:**

- Provide the appropriate number of participating students (6–15, unless otherwise agreed).
- Ensure access to an appropriate space for conducting classes if held on school grounds.
- Ensure designated school staff (Admin or FRC) remain in the area of the class throughout the session.
- Ensure parents provide transportation and a staff member provides supervision of participating students outside session hours.

## **7. Contract Renewal and Scheduling**

- **Advance Notice** : To accommodate coach availability and scheduling, **Maryville After School Program** must notify **Area 502 Mixed Martial Arts** at least **2 weeks in advance** if they intend to renew or extend the program for additional sessions.
- This advance notice ensures proper planning, scheduling, and staffing to provide a seamless continuation of services.

## **8. Duration and Termination**

- The program will commence on an agreed-upon start date and run for 6 weeks.
- Either party may terminate this agreement with a 14-day written notice if obligations are not met.
