

Bylaws for FSDT Booster Club Inc.

Article I - Name & Purpose

1. Name

The name of this organization shall be the *FSDT Booster Club Inc.*, hereinafter referred to as the "Club."

2. Purpose

The Club is organized exclusively for charitable and educational purposes under Section 501(c)(3) of the Internal Revenue Code.

- To support and promote the activities of the Franklin-Simpson High School Dance Team.
- o To encourage parent and community participation.
- To raise funds to enhance and supplement the program not provided by the school district.

Article II - Membership

1. Eligibility

Membership shall be open to parents, guardians, alumni, faculty, staff, and community supporters of Franklin-Simpson High School.

2. Dues

The Club may collect annual membership dues as set by the Board.

3. Voting Rights

Each member in good standing is entitled to one vote.

Article III - Officers

1. Officers

The officers shall be: President, Vice President, Secretary, Treasurer, and such

additional officers as deemed necessary.

2. Duties

- President: Preside over meetings, act as chief spokesperson, coordinate with school administration.
- o Vice President: Assist President; assume duties in President's absence.
- o Secretary: Keep minutes, maintain records, handle correspondence.
- o Treasurer: Manage all funds, keep accurate records, present financial reports.
- Senior Parent Representative: Assist with parent coordination, coordinate awards and recognition

3. Election & Term

- o Officers shall be elected annually by the membership.
- o Term of office is one year, beginning July 1 and ending June 30.
- o Officers may serve consecutive terms if re-elected.

4. Vacancies

Vacancies shall be filled by appointment of the Board until the next regular election.

Article IV - Board of Directors

1. Composition

The Board of Directors shall consist of the elected officers and the FSHS Dance Team Coaches (or designee) as non-voting advisors.

2. Powers

The Board shall conduct business of the Club between general meetings, approve fundraising plans, and oversee committees.

3. Quorum

A majority of the Board constitutes a quorum.

Article V - Meetings

1. General Membership Meetings

- Held at least bi-monthly at a time and place designated by the Board.
- o All members shall be notified at least 7 days in advance.

2. Board Meetings

Held as needed at the call of the President.

3. Quorum

 At general meetings, 10 members OR 25% of membership, whichever is fewer shall constitute a quorum.

Article VI - Committees

- 1. **Standing Committees** may include Fundraising, Membership, Communications, and Audit.
- 2. Special Committees may be established by the President or Board as needed.
- 3. Audit Committee shall review financial records annually before the end of the fiscal year.

Article VII - Finances

1. Fiscal Year

The fiscal year shall be July 1 – June 30.

2. Banking

All funds shall be kept in a bank account in the name of the Club.

3. Disbursements

o All checks require two unrelated officer signatures.

o Expenditures over \$5,000 require prior approval by membership vote.

4. Records

The Treasurer shall present a written financial report at each meeting.

Article VIII - School Relationship

- 1. The Club shall operate as a separate legal entity from Franklin-Simpson High School and Simpson County School District.
- 2. The FSHS Dance Team Coaches (or designee) shall serve as advisors and retain authority over the use of school facilities and student involvement.

Article IX - Dissolution

In the event of dissolution, assets shall be distributed to Franklin-Simpson High School or another nonprofit organization with 501(c)(3) status, in compliance with IRS regulations.

Article X - Amendments

These bylaws may be amended by a **two-thirds (2/3) vote** of members present at a general meeting, provided that notice of the proposed amendment has been given at least 14 days in advance.
