Proposal 46R3 - Numerous adjustments to the doors and hardware which were recommended during field measurement. This additional cost is for the upcharge for some of the specialty elements. *A time extension of 5 days is being granted for this portion of work only*. ADD \$21,462.

Proposal 59R - The existing access control system is not capable of accepting the new wired door hardware as the existing system is a wireless system. The expansion of the system will allow for the entire system to be a hardwired connection from the access control system to the access control hardware. *A time extension of 20 days is being granted for this portion of work only*. ADD \$48,414.

Proposal 62 - Sprinkler head locations must be modified to accommodate inspector's comments and receive final This will allow the access control doors to operate reliably through a hardwired connection. ADD \$1,663. occupancy.

Proposal 63 - Lights were specified in classroom 31 that were not color tunable. The design intent was to provide color tunable lighting for the FMD classroom. *A time extension of 4 days is being granted for this portion of work only*. ADD \$2,586.

Proposal 64 -The existing ceilings in the kitchen were not capable of accepting the specified lighting 4fixtures. New fixtures will be provided that fit into the existing light fixture locations. *A time extension of 7 days is being granted for this portion of work only*. ADD \$ 8,525.

Proposal 65 - Adjustment of the brick allowance since the brick was slightly less expensive than anticipated. DEDUCT \$1,767.
