Partial Gutter Replacement

Along the length of radiused gutter:

- We shall remove approximately 60 LF of rusted-out gutter
- We shall install new gutter in place of that which we removed
 - o The new gutter shall be formed from 24 gauge galvanized steel having a high-quality factory paint finish; we will match the color of the existing gutter as closely as possible, but due to fading a direct match may not be possible
 - We shall match the profile of the existing gutter
 - We shall install new drops (where the downspout connects to the bottom of the gutter) at existing downspout locations along this length of new gutter
- We shall replace deteriorated caulking at all remaining gutter joints, gutter laps, and along "drops" (where the downspouts connect to the bottom of the gutter) using a high-quality elastomeric sealant
 - Joints shall be cleaned and prepped prior to installation of new sealant

Notes & Exclusions:

- We shall do our best to match the color of the existing gutter; however, due to fading & current color availability a direct match may not be possible
- We have not included any downspout replacement

Full Gutter Replacement

Along the entirety of the existing gutter system:

- We shall remove and dispose of the existing gutters (approx. 470 LF)
 - o The existing gutters are "apron style", meaning that they incorporate a flange that is sleeved under the metal roof panels; this flange serves as securement for the gutter, and also functions as a built-in dripedge detail. We shall slice the back of the existing gutter, leaving the flange intact; this flange will serve as a drip edge and securement point for the new gutter
- We shall install new gutter in place of that which we removed
 - The new gutter shall be formed from 24 gauge galvanized steel having a high-quality factory paint finish; we will match the color of the existing gutter as closely as possible, but due to fading a direct match may not be possible
 - We shall match the profile of the existing gutter
 - We shall install new drops (where the downspout connects to the bottom of the gutter) at existing downspout locations along this length of new gutter; the existing downspouts shall be reused- they will be connected to the new downspout drops

Notes & Exclusions:

- o We shall do our best to match the color of the existing gutter; however, due to fading & current color availability a direct match may not be possible
- We have not included any downspout replacement
