- 7. Funding Partner will provide interim grant reports as Blue Grass Community Foundation may request during the grant period.
- 8. Funding Partner will allow representatives from Blue Grass Community Foundation to make scheduled site visits for the purpose of program evaluation.
- 9. Funding Partner will submit a final report via the Blue Grass Community Foundation's Online Grant Portal for the grant project by the end of the grant period.
- 10. Funding Partner will return to Blue Grass Community Foundation any unexpended funds or any portion of the grant that is not used for the purposes specified herein.
- 11. In all forms of public recognition and communications about this project, Funding Partner agrees to acknowledge the **Woodford County Community Fund**.
- 12. Blue Grass Community Foundation reserves the right to discontinue, modify or withhold any payments under this grant award or to require a total or partial refund of any grant funds if, in the Foundation's sole discretion, such action is necessary: (a) because Funding Partner has not fully complied with the terms and conditions of this grant; (b) to protect the purpose and objectives of the grant or any other charitable activities of the Foundation; or (c) to comply with the requirements of any law or regulation applicable to the Funding Partner, the Foundation, or this grant.
