

TERMS AGREEMENT

Online traveler registration: After receipt of signed terms, online traveler registration will be set up for your group and those instructions will be sent to you. Travelers will have until the registration deadline date noted above to register using an online link we will provide. All travelers must register including teachers and other chaperones.

Adding travelers/Fee: After open registration has closed, you may add travelers to the group up to 45 days till your trip departure date only if space is available with all vendors. The trip price for late registrants is subject to increase due to rising costs with such vendors. An administrative fee of \$50 will be charged for each late registration that occurs after vendor bookings. A waitlist will be available through the traveler registration link.

Minimum travelers required: The trip price is based on a minimum number of travelers. If the minimum number of travelers is not reached, modifications to the trip may be made and/or the price of the trip may increase to cover additional vendor costs.

Trip price/Travel dates: The trip price and travel dates are not confirmed until we receive traveler registrations and deposits. Trip price and travel dates are subject to change due to airline availability and unforeseen tax or fuel surcharge increases.

Deposits/Payments: \$100 deposit per paying traveler required and due two weeks after traveler registration deadline to confirm booking. Deposits are non-refundable and applied toward the trip price. 75% of remaining balance is due 90 days before trip start date, and final balance due 30 days from trip start date. All payments are non-transferable. Payments can be made via credit card (fee applies), ACH (fee applies), or check mailed to 16400 US HWY 331 S, B2, #263, Freeport, FL 32439.

Returned check fee: A \$15 returned check fee will be charged for any returned check.

Accommodations: Trip price includes dormitory style accommodations. If different rooming arrangements are needed, additional charges may apply.

Gratuities: Vendor tips are included in your trip price, but a tip for your Appleseed Tour Director is not. We appreciate your consideration for tipping Tour Directors as they are with your group throughout the duration of your trip managing the program such as teaching, safety, logistics, and unexpected changes needed due to weather, etc.

Free chaperones: All free chaperones are expected to supervise students, encourage positive participation and oversee their care. Tour guides are not responsible for student supervision.

Baggage limits: Whether traveling by air or ground only, each traveler will be limited to 1 suitcase with a 40 lb. limit, 1 small bag such as a tote or carry-on item and 1 personal item such as a purse. Travelers are responsible for carrying their own luggage and in some cases, this could include carrying your bags up stairs. Please note, travelers are subject to baggage fees charged by the airlines. If flying, check your airline website to verify all baggage fees and requirements.

Name change fee: Account holder is subject to additional charges due to airline name change fees if flying, or the cost of a new airline ticket if an incorrect traveler name is registered.

Cancellations: All cancellations must be made in writing via email or direct mail and received in our FL office by the date of cancellation. Send notice to billing@appleseedexpeditions.com or direct mail. In the event of a cancellation, if such traveler signs up again at a later date for the same trip, they will be subject to an administrative fee of \$100 plus trip price, any late fees prior to canceling and any additional vendor costs.

Refunds: Refunds will be given on a prorated basis. For cancellations received prior to 90 days before the trip departure date, the non-refundable deposit is retained by Appleseed. For cancellations received between 90-61 days prior to departure date, deposit + 30% of the trip price is retained by Appleseed. For cancellations received 60-31 days prior to departure date, deposit + 50% of the trip price is retained by Appleseed. No refunds will be given for cancellations received 30 days or less prior to the trip departure date. If a trip has been postponed, the refund policy is based on the original travel dates.

Trip cancellation insurance: The price of your trip does not include trip cancellation insurance. In the event of a cancellation, travelers may lose a portion or all of their funds paid. It is strongly recommended that travelers purchase trip cancellation insurance to recover funds they may possibly lose due to a cancellation. Travel insurance will be offered through the traveler's online account during registration.

Right to trip modification: Appleseed Expeditions shall have the right, at any time in its discretion and without liability or cost, to modify any trip or portion of a trip to include but not limited to changes in accommodations, activities, transportation or travel dates in the event of any trip being rendered unsafe or the event of unforeseen circumstances such as a change in weather or reasons beyond our control.

Right to traveler cancellation: Appleseed Expeditions reserves the right to send any traveler home at any time during the trip due to behavioral issues at the traveler's expense or parent's expense in a manner determined by Appleseed Expeditions if Appleseed deems the behavior as a safety risk to other travelers or deems the behavior as causing a disruption to the program. No refunds will be given for any unused portion of the trip.

Entire agreement: This Terms Agreement, those contained on our website and pre-departure materials constitute the entire agreement of the parties with respect to the subject Appleseed Expeditions and supersede any and all previous communications between the parties, whether written or oral, with respect to such subject matter. This agreement is deemed to be entered into and consummated in the state of Florida and shall be construed in accordance with the laws of the state of Florida. Any legal action relating to this agreement shall be brought and maintained exclusively before the superior court located in Walton County, Florida, USA.
