AMENDMENT TO THE AGREEMENT BETWEEN  
WOODFORD COUNTY PUBLIC SCHOOLS  
AND  
THE UNIVERSITY OF KENTUCKY

I. INTRODUCTION:

A certain Agreement was entered into between the University of Kentucky, College of Medicine, Department of Orthopaedic Surgery and Sports Medicine, hereinafter known as “UK”, and Woodford County Public Schools, hereinafter known as “WCPS”, as of July 1, 2023, for the provision of athletic training services (the “Agreement”). This Amendment made and entered into this 1<sup>st</sup> day of November, 2025 amends that certain agreement between the parties.

II. MODIFICATION:

Section II(A)(1) is hereby deleted and replaced with the following:

1. UK will employ two (2) certified athletic trainers (ATCs) for WCPS. The ATCs will provide training room hours and coverage of all KHSAA and WCPS recognized sanctioned high school athletic practices and all home events. Middle school practices will not have coverage.

Section II(A)(3) is hereby deleted and replaced with the following:

3. UK will provide an ATC who will be on-site for all KHSAA sanctioned home athletic events, including all sports recognized by WCPS for both middle and high school. All high school football games, home and away, will be provided with ATC coverage. High school events, both Varsity and JV, shall take precedence over middle school events. In the event of scheduling conflicts involving multiple home events, priority shall be determined by level of play and risk of contact.

Section IV(A)(1)(c) and (d) are hereby deleted and replaced with the following:

II. TERMS AND CONDITIONS:
