It was recommended by the General Contractor (EH) that the ceiling tile be replaced entirely. The ceilings were replaced in 2019 following an Energy Savings Contract with Trane. Since that time, ongoing roof leaks prior to the start of construction and the HVAC System not being operational during construction have caused the ceiling tiles to break down. Ceiling grid remains in place where possible. In addition to tile replacement, ceiling tile and grid is being replaced in three classrooms where installation of new hydronic piping would not allow ceilings to remain in place. This recommendation was discussed with the Director of Facilities and Architect during the bi-weekly progress meeting, and all agreed it was needed to yield the best result.
