- Attendance and participation in ARC meetings for identified and referred students
- Consultation/collaboration with teachers and other service providers
- Communication with parents, teachers, and administrators
- Monthly invoices with documented services provided, a minimum of one hour will be billed for all services, regardless of the duration.

Bellevue Independent Schools will provide:

- Compensation in the amount of \$50 per hour for services provided from December 1, 2025 through May 29, 2026.
- Adequate work space at Bellevue school locations
- Mileage intra-district between schools

A minimum of one hour will be billed for all services, regardless of the duration.

It is understood and agreed that Mrs. Liana Tyree is an independent contractor in her performance of each and every part of this Agreement and she is not, and has never been, an employee of Bellevue Independent Schools. It is understood and agreed that Bellevue Independent Schools is not associated or connected with the actual performance or details of Mrs. Liana Tyree's services to be performed pursuant to this Agreement. Mrs. Liana Tyree shall be solely liable for all labor, material and other expenses in connection with her services performed pursuant to this Agreement. Mrs. Liana Tyree shall not and is not authorized to make any commitment or incur any charge or expense in the name of Bellevue Independent Schools.

Mrs. Liana Tyree shall be responsible for and pay all taxes and duties levied or assessed on Mrs. Liana Tyree by any governmental authority in connection with or incident to the performance of this Agreement.
