Solid Ground Consulting Engineers, PLLC (Solid Ground) is pleased to provide you with this proposal for Special Inspections Services and Materials Testing for the proposed Henderson County High School Improvements project in Henderson, KY. This proposal details project information, proposed scope of services, schedule and estimated cost.

The project includes two phases. Phase 1 includes an interior renovation of an existing classroom space to a culinary lab space as well as new on roof exhaust fans and new on ground make up air units. Phase 2 includes parking lot improvements to the High School. In phase 2 sections of the asphalt parking lot will be cut out and removed, the substrate will be removed and replaced with new stone base, and new heavy duty asphalt will be installed.

### **Special Inspection and Material Testing Scope of Services**

We will perform Special Inspections and materials testing services for this project in accordance with the International Building Code (IBC).

#### Steel Construction (KBC 1705.2)

- Perform structural steel inspections as per the project specifications.
- Perform field observations to verify the structural steel for compliance with the approved plan documents.
- Perform field observations of anchor bolts required for compliance with the approved plan documents.
- Perform continuous inspection on welds greater than 5/16".
- An inspection of the steel fabricator is not included in this proposal.



#### Site Related Testing

- Site Work specifications reference Transportation Cabinet's Standard Specifications for earthwork, concrete placement and asphalt placement.
- Asphalt shall be tested in accordance with IBC.

# **Schedule**

We request 24-hour notice prior to providing on-call personnel to enable us to schedule the work efficiently.

# **Compensation**

Based on the work scope described previously, we propose the following lump sum fees for our Special Inspection Services:

- Phase 1: Start of construction January 2026 and shall be completed July 2026 (7 months): \$2,000.00
- Phase 2: Start of construction June 2026 and shall be completed July 2026 (1 month): \$3,000.00
- Alternate #1: Asphalt Paving: \$1,900.00

### **Payment Terms**
