

Enrollment

- Enrollment in Preschool through Grade 12 as of November 12, was 1300.
- Enrollment in Kindergarten through Grade 12 as of November 12, 2025 was 1248.
- Non-Resident Enrollment for attendance month 3 accounts for 5.4% of the student population.
- Non-Resident 5.4% enrollment encompasses: 21% Campbell County, 1% Bellevue, 11% Dayton, 9% Fort Thomas, and 38% Covington.
- Non-Resident enrollment of 5.4% includes the following breakdown: Newport High 36% Newport Intermediate 23%, Newport Primary 26%, and School of Innovation 11%.



Attendance

- Attendance Month 3 (September 30, 2025 to November 3, 2025)
 - o Newport Primary- 95.33%
 - Newport Intermediate- 95.53%
 - Newport High 94.64%
 - Newport Independent 95.11%
- Three schools within the district are exceeding the district attendance goal of 95% for month 3.
 - We have experienced a drop in daily attendance beginning with the return from fall break. Trend data shows an increase in tardy to school at Newport Primary and Newport Intermediate with late check in to school being the greatest factor. All guardians of students who have accumulated 9 or more tardy events have received written communication regarding truant status and have been encouraged to address tardiness and to engage with their child's school to address barriers causing lateness.
 - Next steps at the district level will be to increase messaging about the importance of attendance through sources such as Attendance Works and to increase awareness and access to tools such as ParentGuidance.org and the Cook Center for Human Connection.

Growth Factor

The Growth Factor has been submitted to the Kentucky Department of Education. KRS 157.360(8) identifies the purpose of Growth Factor as, "Program funding shall be increased when the average daily attendance in any district for the first two months of the current school year is greater than the average daily attendance of the first two months of the previous school year." The percent of growth is multiplied by the previous school year's end-of-year ADA to determine the additional ADA funding a district will receive.

Based on Prior Year SAAR with growth, the required AADA for January Growth and increased funding would be 1,257.55. Given current enrollment, classroom capacity, and projections we will not be receiving additional funding through Growth Factor for January reporting. Currently our Grade K Full Day AADA is 92.56, Grades 1-12 Full Day AADA is 1,011.19 for a total AADA of 1,103.75. These numbers do not reflect our performance based and virtual students who earn attendance through grades per course at the end each semester and are reported through a Record V.

Investigations

Residency verification checks and review of submitted information continues as one piece of our system to ensure accuracy in enrollment. November investigations include one on-going guardianship case, one case with out of state residency for a portion of the instructional week, and seven denials of enrollment due to residency. Continuous Improvement Process

Within Phase Two of the Continuous Improvement Process all schools and district have submitted the following diagnostics by November 1, 2025:

- Needs Assessment- stemming from local accountability measures as State Assessment Data is embargoed.

- District Safety Report
- District Trauma Informed Approach Plan.

Phase Three of the Continuous Improvement Process is in progress and due by January 1, 2026.

- Comprehensive School Improvement Plan
- Superintendent Gap Assurance

Leadership has met at the district level to review identified Key Core Work Processes to be addressed within the plan for leverages and areas of improvement. With areas of growth identified by department, each leader is working on department aims and drivers. Included within the work is cross department and holistic leadership team meetings to ensure our focus is on positive growth outcomes for students and staff.

Behavior

• Student behavior Tiers is based solely on the number of behavior referrals submitted by staff. Effective Tier I should reflect 80% or greater of the population. Tier II would reflect 15% and Tier III would reflect no greater than 5%. Use of behavior referrals and Tiered data are made at the recommendation of KDE.
