- to pay for a membership, dinner, or any other activity that provides a benefit to the donor, advisors, or related parties;
- to pay for personal expenses incurred by a relative, including tuition; or
- to provide any other substantial private benefit to any individual or to a charitable entity for the benefit of a specified individual.

Donors, advisors, or related parties may NOT receive grants, loans, compensation, or similar payments (including expense reimbursements) from this fund. You are also certifying that no more than an incidental benefit will be received by the donor advisor(s) named above or any family member or other individual or entity connected with such donor-advisor(s) as a result of this grant.
