



Maryville Elementary teachers will be collaborating with Two Chicks and Arithmetics in Numeracy Counts: Supporting the Teaching of Elementary Fractions (Grades 3–5). The following details what they will do.

The professional learning series is designed to strengthen teachers' confidence and effectiveness in teaching fractions, which is one of the most challenging areas in elementary math. Over the course of five onsite, interactive coaching sessions, teachers will learn practical, classroom-ready strategies through live modeling, guided practice, and collaborative problem-solving.

Our teachers will explore hands-on methods for helping students understand fractions conceptually. These include activities using visual models, manipulatives, number lines, and real-world connections that make fractions feel meaningful and accessible to all students.

Teachers will also learn real-time assessment techniques such as simple checks, student conversations, and observation tools that help teachers immediately see what students understand and where they need support. Between sessions, teachers will receive ongoing feedback and coaching, ensuring they feel supported as they try out new strategies in their own classrooms.

All teachers will receive a resource folder full of ready-to-use materials, planning tools, and fraction activities.
