Congratulations on a great season!

I have prepared a state tournament packet for you and your parents. In this packet your parents will find information about the hotel we are staying at, the Farnham Dudgeon Arena Frankfort Convention Complex (where all the wrestling will take place), detailed itinerary of times and wrestling sessions of the tournament, directions from the school to the Farnham Dudgeon Arena, and most importantly the CODE of CONDUCT.

The 2011 KHSAA State Wrestling Tournament will be held on Thursday (February 17), Friday (February 18), and Saturday (February 19). We will be leaving on Wednesday (February 16) at approximately 12:00 PM and returning Sunday (February 20) approximately 12:00 PM. During the tournament sessions the team will remain at the Farnham Dudgeon Arena.

New school policies and procedures require me to inform the student/athlete and parent/guardian the rules and regulations of Christian County High School when taking an overnight trip as a representative of Christian County High School. I have enclosed a Code of Conduct form that is to be read and signed by the student/athlete, the parent/guardian, coach, and chaperone, which informs everyone about the conduct that will be expected on this trip. **The Code of Conduct is to be signed and turned back into one of the coaches by Wednesday February 16, 2010.**

# CODE OF CONDUCT

## (Christian County High School Wrestling Team KHSAA State Tournament )

1. All athletes, managers, coaches, and guests shall behave at all times as ladies and gentlemen, refraining from actions that might bring discredit upon themselves, their school, their family or friends, the state tournament, or upon the Christian County Wrestling Team.
2. Student/Athlete shall not possess or consume alcohol, drugs, tobacco, or any form of artificial stimulant while traveling to, during or returning from the KHSAA State Tournament site. (Drugs prescribed by doctors are permissible,) Violators will be expelled from the state tournament and turned over to the proper authorities. The coaches and/or the chaperones will notify parents/guardians and school principal of the action taken.
3. Male and female members will not visit each other in their rooms at any time without a coach or chaperone being present.
4. Members shall not yell, talk loudly, or disturb others in the hotel, nor throw or drop anything from hotel windows or balconies.
5. At the KHSAA State Tournament **all students/athletes shall be in their own rooms by designated curfews and will not leave the rooms after curfew.**
6. Student/Athlete shall not participate in any activity that might cause personal injury to themselves or to another person. Any participant found in violation of hotel safety codes or criminal laws may be sent home at the student's/parent's/guardian's expense. The coaches and/or the chaperones will contact the parent/guardian and school principal.
7. The Coaches has the right to take immediate action when violations occur including sending individuals home at their own expense. In the event this occurs, the parents/guardians and school personnel will be contacted by the coaches and/or chaperones.
8. Serious misconduct shall be reported to the principal and parents/guardians who shall be advised that a student/athlete may be barred from participation in KHSAA State Wrestling Tournament activities.
9. Each student/athlete must sign a Christian County High School Wrestling Team KHSAA State Tournament Code of Conduct form.
10. The school's administrators, coaches, and the police/canine department will conduct a check of the students' luggage for alcohol, drugs, tobacco, and/or weapons. Students must have all luggage checked on schedule in order to be a part of the trip. No contact with the luggage may be permitted once the check has occurred. In the event that any illegal item is found, the student will be removed from the trip and school disciplinary action for possession of such items will be initiated.
11. I agree that, upon violation of the Code of Conduct, I will vacate the room and/or withdraw from the KHSAA State Wrestling Tournament activities if requested to do so by the KHSAA staff or local coaches or chaperones. Serious offenses of this code of conduct shall be reported to my principal and parents/guardians who shall be advised that I may be barred from participating in KHSAA State Wrestling Tournament activities.
12. **I WILL FOLLOW ALL RULES, POLICIES, AND PROCEDURES UPHELD BY CHRISTIAN COUNTY HIGH SCHOOL AND THE CHRISTIAN COUNTY BOARD OF EDUCATION.**
