A. Student/Staff Recognition

Principal Brandon Blackburn shared with a brief recap of activities of both academic and athletic achievements and what is happening to plan for the upcoming school year.

D. District Administrator Reports

Kim Clevinger, Instructional Supervisor, provided an update on several ongoing initiatives across the district. She discussed the implementation of Flex PD, noting strong staff participation and continued alignment to district goals. Mrs. Clevinger also highlighted upcoming and recent FRYSC sponsored family events, emphasizing their positive impact on student engagement and community support. In collaboration with teachers, the Math PLC is working through the current textbook adoption process, reviewing materials and identifying high-quality resources to support instruction. Mrs. Clevinger shared that the district continues to focus on providing strong mentoring and instructional support for teachers through the Mentor Program. She also reported that the Science PLC, in partnership with Sarah Blackburn, is actively developing and refining K–12 science instructional plans to ensure vertical alignment and coherence throughout grade levels. Finally, Kim updated the board on the district's Trauma-Informed Care Plan, which is being incorporated into the Comprehensive School Improvement Plan (CSIP) and supported by data from the recent Needs Assessment.

Taffie Wells, Instructional Supervisor, DAC, and Preschool Director, informed the board that Kentucky Summative Assessment data, along with the corresponding indicator rankings, will be released on November 19. She noted that additional discussion, guidance, and information will be provided to staff and stakeholders following the release to support understanding of the results and next steps for the district.
