Cecilia Valley Elementary currently hosts 500 students within the Hardin County School District. Cecilia Valley Elementary School opened as a brand new school in January 2018 and is located in Cecilia, KY with a population 618 (2019 Census). The median household income is \$67,689 and 41% of people in Cecilia live below the poverty line. Cecilia Valley Elementary School serves Preschool through 5th grade students, including a Low Incidence Special Education program and two Outdoor Preschool Program. Mr. Casey Goodman is serving as the Principal; Ms. Michaela Priddy is serving as Assistant Principal; Mrs. Tiffany Neuman is serving as the CVES Counselor and Mrs. Donna Propes is serving as the Family Resource Coordinator.

Cecilia Valley engages our families in the improvement planning process through parent representatives on our Site-Based Decision Making, as well as each SBDM committee including a parent representative.
