CONDITIONS FOR APPROVAL

Tuition students will be accepted provided that space is available, and that the student meets established criteria for acceptance. Criteria includes: (1) Space availability; (2) Academic performance data and student transcript; (3) Attendance; (4) Behavior - the student must not have been suspended or expelled from the sending school during the past school year; and (5) payment of ~~\$25.00 enrollment processing fee and tuition.~~

Non-resident tuition students, if accepted, are enrolled for one (1) school year only. At the end of the school year, the performance of the student, academically and behaviorally, will be evaluated to determine continued enrollment. If, at any time during the school year, a space availability problem, academic problem(s) or behavior problem(s) develops, or tuition is not paid as agreed upon in a timely manner, the non-resident tuition student may have his/her enrollment terminated.

A non-refundable deposit of \$500 is due on or before **July 15th**, in order to hold your child's place. This payment will be applied to the tuition balance.

Once your student has officially registered for the school year, payments can be made via credit/debit card through Infinite Campus. When paying by credit/debit card, please add \$100.00 to offset the credit/debit card processing fee. The processing fee is charged by the card company, not by the Beechwood Board of Education.

TUITION PAYMENT OPTIONS

Option 1	1 Payment	Full payment by July 15th Receive \$ 100 discount if paid in full by check or cash. Discount is not available for online payments.
Option 2	2 Payments	½ of tuition (\$) due on or before August 15th ½ of tuition (\$) due on or before January 15th Late payments are subject to a \$25 late payment fee. No tuition payment reminders will be sent.
Option 3	4 Payments	¼ of tuition (\$) due on or before August 15th ¼ of tuition (\$) due on or before October 15th ¼ of tuition (\$) due on or before January 15th ¼ of tuition (\$) due on or before March 15th Late payments are subject to a \$25 late payment fee. No tuition payment reminders will be sent.

Contract/Conditions for Non-Resident Tuition Students

In the event of court action to enforce this agreement, Beechwood shall be entitled to its costs of collection including reasonable attorney fees.

Tuition costs are subject to review each and every year by the Board of Education. The current tuition schedule will be as follows:

In-State Staff child* = \$0.00

Out of State Staff child = **Out-of-state non-resident children of full-time staff enrolled after August 1, 2017 shall pay a tuition rate **equal to the Kentucky state contribution** for each child enrolled in the District.

In-State Non-Resident/Non-Staff student = \$4900

Out of State Non-Resident/Non-Staff student = \$6900

**Out-of-state non-resident children of full-time staff enrolled after August 1, 2017 shall pay a tuition rate equal to the Kentucky state contribution per child for each child enrolled in the District.
