That said, if moving Gallatin is the only path of changing out Collins then my vote must reflect that logic, however flawed. It would be more appropriate to move Woodford into the 11th and keep Collins. So much of this is about Boys BB, which is a "reality" that is unfortunate and short-sighted. But if that paradigm must be taken at face value, then we must conclude that Woodford plays with mostly Lexington kids at this point, and the consistency within the District's balance is fraught as a consequence.

North Oldham High School	District 29	When new small school comes in, they only offer a handful of sports. Cornerstone Christian is only going to offer three sports from what I have been told: men's basketball, women's basketball, and volleyball. It was stated at our last meeting that Cornerstone could not be added to a three-team district because, in essence, it would still be a three-team district. Then logic would say, that if Cornerstone was added to a current 5-team district, it would really still be a five-team district. No reason to upset the entire apple cart when Cornerstone is basically going to be a non-factor in its current size. If Cornerstone grows over the next few years and they are able to offer more sports, then the region can re-visit the realignment issue at that time.	There is no logical reason to move Collins out of their district and break up the natural district rivalry, etc. If the schools in the 30th district are strongly opposed to becoming a six-team district, then Cornerstone should be placed into the 29th district where there is an open spot. The difference in the distance between Collins and Cornerstone coming to the 29th is negligible, so no reason to realign a well-established 30th district for a new, small school when the 29th has room for them. Adding Cornerstone to the 29th district is the easiest, simplest, and most common sense solution.
Oldham County High School	District 29	I think that there is a big difference including a school that is coming in playing 3 sports impacting district/regional play than a school with all 7 established sports. A school only fielding less than 50% of the district championship sports should not impact the entire region. We would be uprooting long standing traditions and district/region alignment for a school participating in 3 championship tournaments for postseason play. When asked at an 8th Region AD meeting, Cornerstone Christian's AD could not tell the group the high school enrollment of his school and only said they hoped to add the additional 4 sports (boys and girls soccer, baseball and softball). They did not have facilities or programs in place according to their AD.	I believe the 8th region should be left alone and remained as is only moving Cornerstone Christian to the 30th region.  29th, 31st and 32nd districts would remain in tact  As a region, we should either be ok with 3 or 6 team districts or not. We should not say it is ok to have a 6 team in one district but not the other. If we are not and want to have 4-5 team districts throughout the 8th region, we should have to realign the entire region, which may lead to realigning the entire state. Grant County High School	District 32	Since this is just my second year here at Grant County, I'm not sure if Cornerstone had a "probationary" period, but in Colorado (where I spent the 15 years previously before coming to Grant County) a school had a 2-year probation period where they could play game but not be eligible for any post season competition. This allowed them to show that they could participate in the sports they offered, host at reasonable venues, handle logistics of running events, etc before they became full members eligible for post season competition. It kept some new schools from becoming members of CHSAA and showed that others we're capable of being good members of the association.	My main reason for voting yes for the proposal sent in was that it was the least movement in satisfying no 3-team or 6-team districts. Trimble could have moved back with the Oldhams, but there still would have been 6 teams in district 30. Eminence & Henry County could go with the Oldhams, but you'd have the same situation in 30. I do think there should be at least one school added to district 29 to eliminate the 3-team district. Collins and Trimble could both go to 29, and we'd have districts with 4, 5, 5 & 4.5 teams (Cornerstone being the .5 with only 3 sports to start with.)
