



PERFORMANCE FACTOR

The tournament performance factor will be calculated after each sport season and applied on a sport-by-sport basis, with the exception of track & field and swimming & diving, which will continue to use only enrollment.

The tournament performance factor is a three-year cumulative total per division. Programs that have accumulated at least six tournament performance factor points will be promoted to the division with the next highest enrollments from the previous year. No program will be moved more than one division per year.

If the tournament performance factor points total over the previous three years falls below the six points in all divisions, promoted programs will move down one division of lower enrollments, unless the school enrollment places them in the higher division, per tournament regulations for that sport.

When a new co-op forms, the co-op will receive a point total equal to the combined total of all schools in the co-op.

The tournament performance factor will be calculated based on Tournament Series advancement and points will be accumulative for a three-year period. The points earned are those assigned to the highest level of tournament success, not a cumulative total of points. The maximum points a team can earn in a given season is four (4) points.

Points will be credited based upon the following system.

Bracketed Sports

Baseball, Basketball, 11-player Football, Hockey, Soccer, Softball, Volleyball, Wrestling

- (a) 1 point for advancing to the state quarterfinal, sectional final or Level 3 11-player FB, (final 8 teams)
- (b) 2 points for advancing to the state semifinal (final 4 teams)
- (c) 3 points for advancing to the championship game
- (d) 4 points for winning a state title

Non-bracketed Sports

Cross Country (Boys & Girls)

- (a) 1 point for qualifying for the state meet
- (b) 2 points for placing 3rd or 4th place at the state meet or for Sectional Champion
- (c) 3 points for winning the state runner up
- (d) 4 points for winning the state title

Golf (Boys & Girls)

- (a) 1 point for qualifying for the state meet
- (b) 2 points for placing 3rd or 4th place at the state meet or for Sectional Champion
- (c) 3 points for winning the state runner up
- (d) 4 points for winning the state title

Gymnastics

- (a) 1 point for qualifying for the state meet
- (b) 2 points for placing 3rd or 4th place at the state meet or for Sectional Champion
- (c) 3 points for winning the state runner up
- (d) 4 points for winning the state title

Tennis (Boys & Girls) Division 1

- (a) 1 point for Sectional Champion
- (b) 2 points for placing 3rd or 4th place at the state meet
- (c) 3 points for winning the state runner up
- (d) 4 points for winning the state title

Tennis (Boys & Girls) Division 2

- (a) 1 point for Sectional runner-up (if schools tie, all schools receive points)
- (b) 2 points for Sectional final champion (final 4)

- (c) 3 points for winning the state runner up
- (d) 4 points for winning a state title

After application of the tournament performance factor, divisions will be assigned based upon the season regulations/tournament procedures for that sport. A team cannot be moved down a division due to another team's promotion if the aforementioned team has earned any tournament performance factor points in that division during the previous three years. The next smallest school without tournament performance factor points in that division during the previous three years will be moved down.

If a team is moved down a division, the next biggest school will move up if it is necessary to fulfill the tournament procedures and schedule for that sport. The previous school year enrollment will be used to break a tie in enrollment.

Performance Factor Process Results in Divisional Movement

STEVENS POINT, Wis. – The Wisconsin Interscholastic Athletic Association performance factor initiative has advanced through the process for the first time with a review of the fall sports for implementation in 2024.

An ad hoc committee consisting of 11 superintendents/district administrators, six athletic directors, one principal and one principal/athletic director proposed the performance factor process, which was approved by a 265-115 membership vote at the 2023 Annual Meeting for implementation in 2024-25. The initiative promotes school programs that reach a threshold of tournament success based on a performance point system allocated over a three-year period.

School programs reaching the six-point threshold during the past three seasons are placed in the division containing the next largest set of enrollments from where the schools' enrollments would place them for each respective sport other than track & field, swimming & diving—which do not have a team component to advancement in the Tournament Series—and sports with only one division. Schools are restricted to moving up a maximum of one division from the previous year's placement.

This new initiative affords schools the opportunity to request to move down a division with lower enrollments for all fall sports except football next year. The inaugural Classification Committee reviewed nine such requests for girls volleyball, three for boys soccer, four for both boys and girls cross country, two for girls tennis and one for girls golf. The committee approved four requests in girls volleyball, one in boys soccer and one in girls tennis.

The school sports programs that have accumulated at least six points to engage a promotion to a division with higher enrollments—if their 2024-25 tournament placement enrollment doesn't initially move them up a division—are listed below. Please note that programs that meet the performance points threshold to be promoted and are initially assigned to a lower enrollment division—based on their 2024-25 tournament assignment enrollments—will be promoted back into the division they competed in during the most recent season's Tournament Series.

The performance factor process affords schools the opportunity to appeal their promotion to the division with the next largest enrollments based on performance points. Of the 62 programs listed above that compiled points to engage in a promotion, 24 appeals were submitted. The Classification Committee reviewed and evaluated these with one approval.

The WIAA will determine the Tournament Series assignments to be released for all 2024 fall sports except football and girls volleyball in early January, 2024. Girls volleyball, which is expanding to five divisions in 2024, will be posted in February, 2024.

Performance Factor Results in Winter Sports Divisional Movement

STEVENS POINT, Wis. – The Wisconsin Interscholastic Athletic Association performance factor initiative has advanced through the process for the second time with a review of the winter sports for implementation in 2024-25.

An ad hoc committee consisting of 11 superintendents/district administrators, six athletic directors, one principal and one principal/athletic director proposed the performance factor process, which was approved by a 265-115 membership vote at the 2023 Annual Meeting for implementation in 2024-25. The initiative promotes school programs that reach a threshold of tournament success based on a performance point system allocated over a three-year period.

School programs reaching the six-point performance factor threshold during the past three seasons are placed in the division containing the next largest set of enrollments from where the schools' enrollments would place them for each respective sport other than track & field and swimming & diving—which do not have a team component to advancement in the Tournament Series—and sports with only one division. Schools are restricted to moving up a maximum of one division from the previous year's placement.

This new initiative affords schools the opportunity to request to move down a division with lower enrollments. The Classification Committee reviewed 15 such requests for winter sports, including eight for girls basketball, six for boys basketball and two for boys hockey. The committee approved three requests in girls basketball, two in boys basketball and two in boys hockey. Additionally, five schools requested—and were approved—to move to a division of higher enrollments, including three in boys hockey, one in boys basketball and one in girls basketball.

The school sports programs that have accumulated at least six points to engage a promotion to a division with higher enrollments—if their 2024-25 tournament placement enrollment doesn't initially move them up a division—are listed below.

Please note that programs that meet the performance points threshold to be promoted and are initially assigned to a lower enrollment division—based on their 2024-25 tournament assignment enrollments—will be promoted back into the division they competed in during the most recent season's Tournament Series.

In addition, the performance factor process affords schools the opportunity to appeal their promotion to the division with the next largest enrollments based on performance points. Of the 37 programs listed above that compiled the threshold of points to engage in a promotion, 12 appeals were submitted. The Classification Committee reviewed and evaluated these with one approval. It is also noteworthy that 13 of the 35 programs that achieved the six-point threshold competed in Division 1 in 2024 and will be promoted only if their enrollment places them in a division with lower enrollments.

The WIAA will release the Tournament Series assignments for all 2024-25 winter sports later this spring.

An ad hoc committee consisting of 11 superintendents/district administrators, six athletic directors, one principal and one principal/athletic director proposed the performance factor process, which was approved by a 265-115 membership vote at the 2023 Annual Meeting for implementation in 2024-25. The initiative promotes school programs that reach a threshold of tournament success based on a performance point system allocated over a three-year period.

School programs reaching the six-point performance factor threshold during the past three seasons are placed in the division containing the next largest set of enrollments from where the schools' enrollments would place them for each respective sport other than track & field and swimming & diving—which do not have a team component to advancement in the Tournament Series—and sports with only one division. Schools are restricted to moving up a maximum of one division from the previous year's placement.

This new initiative affords schools the opportunity to request to move down a division with lower enrollments. The Classification Committee reviewed seven such requests for spring sports, including three for baseball, two for softball, and one each in girls soccer and boys tennis. Two of those requests were approved in baseball, and one softball, girls soccer and boys tennis.

The spring school sports programs that have accumulated at least six points to engage a promotion to a division with higher enrollments—if their 2024-25 tournament placement enrollment doesn't initially move them up a division—are listed below.

The performance factor process affords schools the opportunity to appeal their promotion to the division with the next largest enrollments based on performance points. Of the 37 programs listed above that compiled the threshold of points to engage in a promotion, 10 appeals were submitted. The Classification Committee reviewed and evaluated these with one approval. It is also noteworthy that 10 of the 37 programs that achieved the six-point threshold competed in Division 1 in 2024 and will be promoted only if their enrollment places them in a division with lower enrollments.

The WIAA will release the Tournament Series assignments for all 2024-25 spring sports later this summer.
