**Consent Agenda Item (Action Item):** Consider/Approve purchasing projection mapping systems for our three high school gymnasiums

**Applicable State or Regulations:** BOE Police 01.11, 04.32; KRS 45A.345-460

**History/Background:** Court mapping projections use high-powered projectors and specialized software to transform sports courts into dynamic 3D display surfaces, creating immersive intro shows, halftime experiences, and interactive graphics that wow fans by making the floor appear to drop away or come alive with digital mascots and effects, elevating the entire game-day atmosphere. This technology, used by NBA teams and now accessible to high schools, relies on precisely warping images to irregular surfaces using media servers for perfect synchronization and impact.

Instructionally, the projections can be used to provide/promote the following:

**Immersive Learning Environments:** Projection mapping can create immersive environments by projecting images and videos onto walls and ceilings, helping students understand complex concepts in various subjects, not just sports.


**Interactive Visual Aids:** Educators can enhance traditional visual aids like graphs, diagrams, and maps by making them interactive and dynamic, creating a unique and memorable learning experience.


**Hands-on Experience:** In technical fields, such as AV production or graphic design, students can get directly involved in creating and planning the projection shows, gaining practical, real-world experience with the technology.

**Complex Topic Explanation:** The technology has been used in university settings to explain complex scientific or social issues, such as the impact of climate change on wetlands, by visually overlaying data and information onto physical models or surfaces.
