Description of the School

Describe the school's size, community/communities, location, and changes it has experienced in the last three years. Include demographic information about the students, staff, and community at large. What unique features and challenges are associated with the community/communities the school serves?

Bullitt County Specialized Programs is comprised of Riverview Opportunity Center (ROC), Bullitt Alternative Center (BAC), Bullitt Virtual Learning Academy (BVLA), Bullitt Advanced Math and Science (BAMS), the Career Readiness Center (CRC), and Spring Meadows. The Specialized Programs currently serves 352 students, grades 6 - 12. These students are from all across the county. The staff is made up of 26 certified employees including the principal, assistant principal and counselor, while there are 21 classified staff across the programs. The Specialized Programs covers multiple facilities in Shepherdsville and Mount Washington, while the BVLA teachers operate out of the Bullitt County campus of Jefferson Community and Technical College.

ROC: Across the programs that run out of ROC (BAMS, BVLA, and CRC), 54% of students are male and 46% female. 83% of our students qualify for either free or reduced lunch prices. Students that are actively receiving special education services are 9% of the student body. ROC has 21 certified staff members, and 12 classified staff members (5 of which are instructional support positions). Of our certified teachers, 2 do not have tenure.

BAC: The Bullitt Alternative Center has a very transient student population. Currently, 65% of our students are male, while 35% are female. Nearly every student enrolled at BAC at any given time qualifies for free or reduced lunch prices. 55% of our current population is actively receiving special education services. 81% of the student population is White, while 5% are Two or More Races, 8% is Hispanic, 3% is Black/African American, and 3% are Asian. BAC has 8 certified staff members, 3 social workers, and 8 classified staff members (5 of which are instructional support positions).

Our primary stakeholders are our students, but other groups include families, staff, businesses, and community members. We ensure involvement and engagement in the improvement planning processes by utilizing student councils, student and parent surveys, PLCs, partnerships with the Shepherdsville Chamber of Commerce and local businesses, the Impact Survey, and various staff-led committees.

School's Purpose

This year, the staff reviewed the school's purpose and decided to keep it unchanged from the previous two years. Smaller teams across the Specialized Programs also worked to accept or change the various missions.

BAC Mission: Help students overcome adversity and achieve success.

CRC and BAMS Mission: Educated. Empowered. Employed.

Spring Meadows Mission: Signaling change and making futures happen.

BVLA Mission: Provide innovative, technology-based educational experiences that will equip our students to succeed in life.

Notable Achievements

Describe the school's notable achievements in the last three years.

Over the past three years, the Specialized Programs have continued to refine and improve. Last year, 11 students, more than any other educational institution in the state, were accepted into Gatton and Craft Academies. We have had more students accepted to Gatton and Craft Academies than anyone else every year now for three years in a row! 22 students graduated from the Bullitt Virtual Night School (BVNS) two years ago, and our Board just approved opening BVNS back up again for the 2025 - 2026 school year. Bullitt Virtual Learning Academy (BVLA) has continued to grow and flourish. New reading and math intervention programs have been put into motion at the Bullitt Alternative Center, along with civics lessons on Mondays, reading/literacy lessons on Wednesdays, and personal finance lessons on Fridays. We have continued to grow our partnership with UK for Dual Credit courses, and have also partnered with WeLead CS for computer science pathways.

Areas of Improvement

Describe areas for improvement that the school is striving to achieve in the next three years.

Areas of Improvement: There are two primary areas for improvement within the Specialized Programs. With the exception of BAMS, ACT scores are in need of improvement, especially in the area of math. We believe this will translate to SATs as well, so it will continue to be an area of focus. Additionally, equity in tier 1

instruction across the Programs is an area for focused improvement. These two areas are the subjects of PDSAs and therefore a focus of our entire staff.

School Safety Report

Pursuant to KRS 158.162, the local board of education shall require the school council or, if none exists, the principal in each school to adopt an emergency plan that must be utilized in case of fire, severe weather, earthquake, or a building lockdown and that: establishes evacuation routes; identifies the best available severe weather zones; develops earthquake protocols for students; and, develops and adheres to practices controlling access to the school building. The emergency plan shall be annually reviewed by the council, principal, and first responders and revised as needed.

In addition to the emergency plan requirements in KRS 158.162, KRS 158.164 requires the local board of education to direct the school council or, if none exists, the principal in each school to establish procedures to perform a building lockdown and to invite local law enforcement to assist in establishing lockdown procedures.

KRS 158.162 also requires the emergency plan be discussed with all school staff prior to the first instructional day of the school year and provided, along with a diagram of the facility, to appropriate first responders. Further, the principal in each school shall conduct, at a minimum, the following emergency response drills within the first 30 instructional days of the school year and again during the month of January: one severe weather drill, one earthquake drill, and one lockdown drill. In addition, required fire drills shall be conducted according to administrative regulations promulgated by the Department of Housing, Buildings and Construction.

Pursuant to KRS 156.095, every public school and public charter school shall provide two (2) evidence-based suicide prevention awareness lessons each school year, the first by September 15 and the second by January 15, either in person, by live streaming, or via a video recording to all students in grades six (6) through twelve (12). Every public school shall provide an opportunity for any student absent on the day the evidence-based suicide prevention awareness lesson was initially presented to receive the lesson at a later time. The information may be obtained from the Cabinet for Health and Family Services or from a commercially developed suicide prevention training program.

KRS 156.095 also requires by November 1 of each year, a minimum of one (1) hour of training on how to respond to an active shooter situation shall be required for all school district employees with job duties requiring direct contact with students. The training shall be provided either in person, by live streaming, or via a video recording prepared by the Kentucky Department of Criminal Justice Training.

Additionally, KRS 156.095 requires all school administrators, certified personnel, office staff, instructional assistants, and coaches and extracurricular sponsors who are employed by the school district shall complete comprehensive evidence-informed training within ninety (90) days of being hired and then every two (2) years after on child abuse and neglect prevention, recognition, and reporting that encompass child physical, sexual, and emotional abuse and

neglect.

Finally, in accordance with KRS 156.095, every public school shall prominently display the statewide child abuse hotline number administered by the Cabinet for Health and Family Services, the National Human Trafficking Reporting Hotline number administered by the United States Department for Health and Human Services, and the Safe Haven Baby Boxes Crisis Line number administered by the Safe Haven Baby Boxes national organization or any equivalent successor entity.

<p>KRS 158.649 requires the school-based decision making (SBDM) council, or the principal if no council exists, to set the school's yearly targets for eliminating any achievement gap. The targets should be established with input from parents, faculty and staff and submitted to the superintendent for consideration and the local board of education for adoption. In addition to being a statutory requirement, intentionally focusing on the achievement gaps that exist among a school's underserved student populations is also a vital component of the continuous improvement process. Schools should use a variety of measures and analysis when conducting its review of its achievement gaps, including a review of the school's climate and culture. Schools are not required to establish long term achievement gap goals; however, schools must establish yearly targets. Additional rows may be added for multiple targets, strategies and activities.</p>
