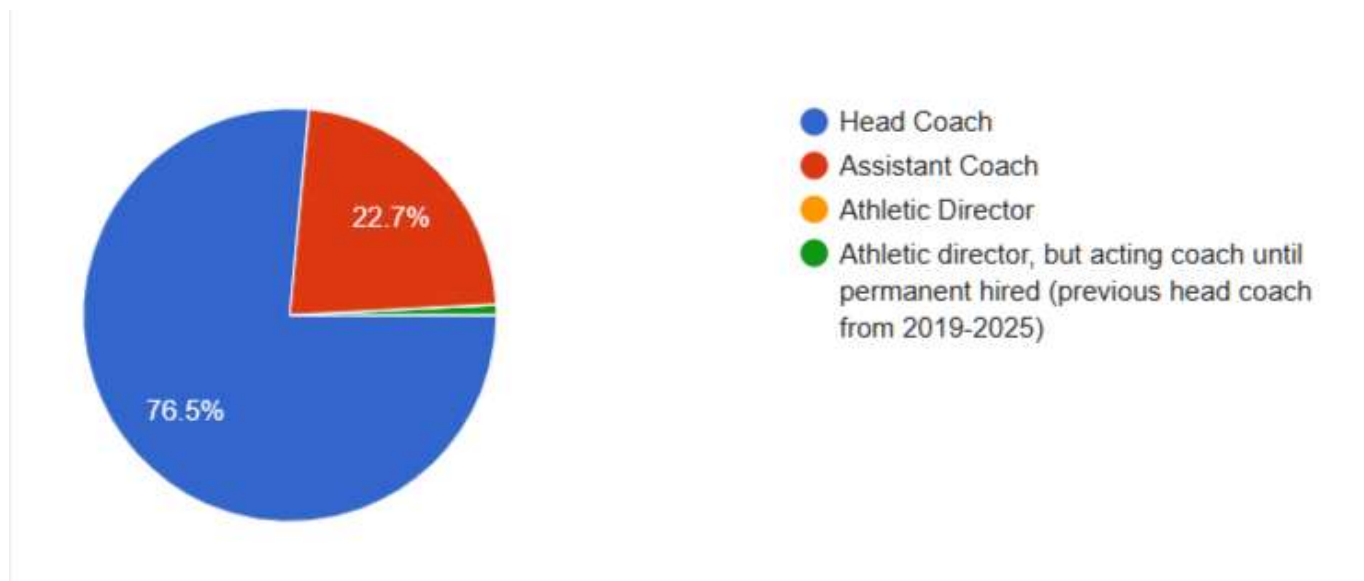
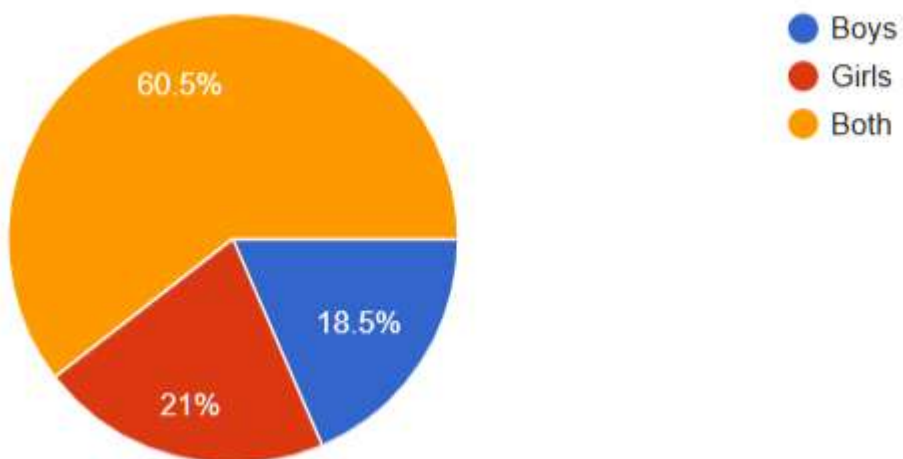

Which team do they Coach?

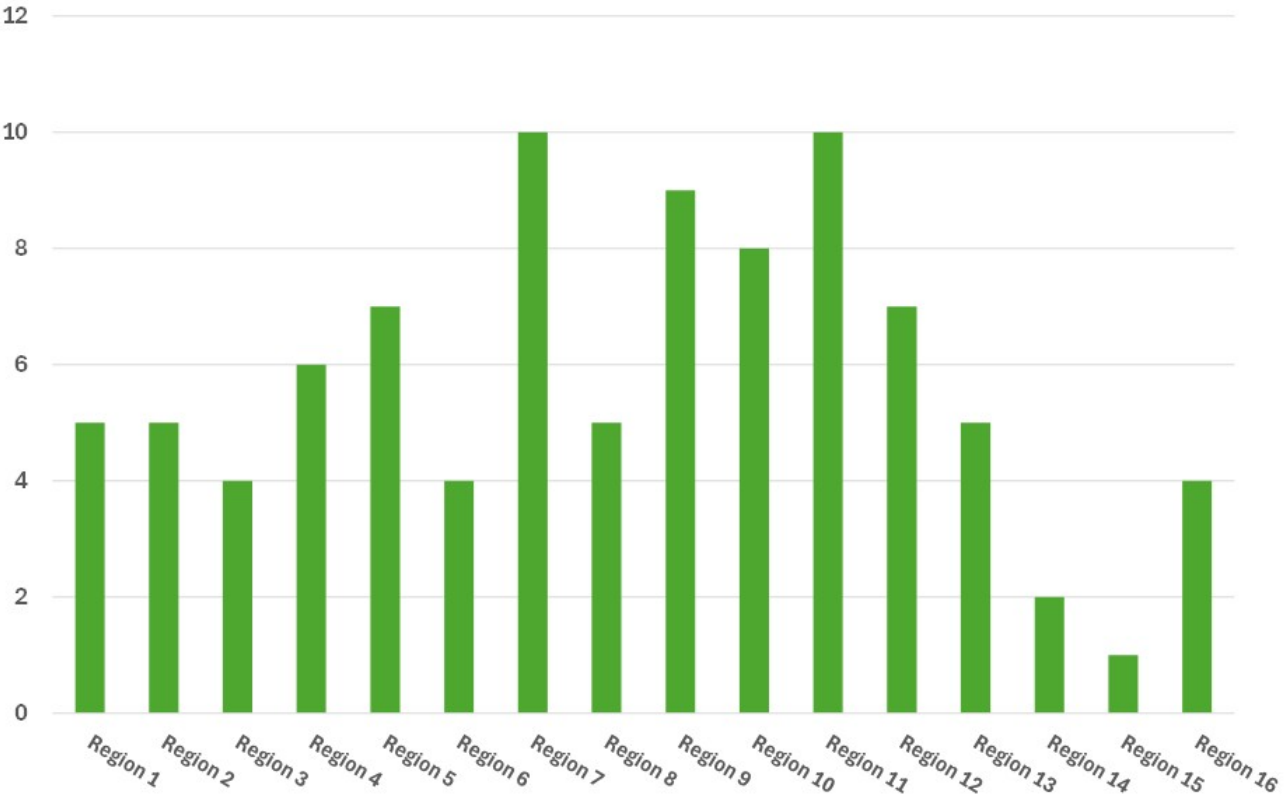


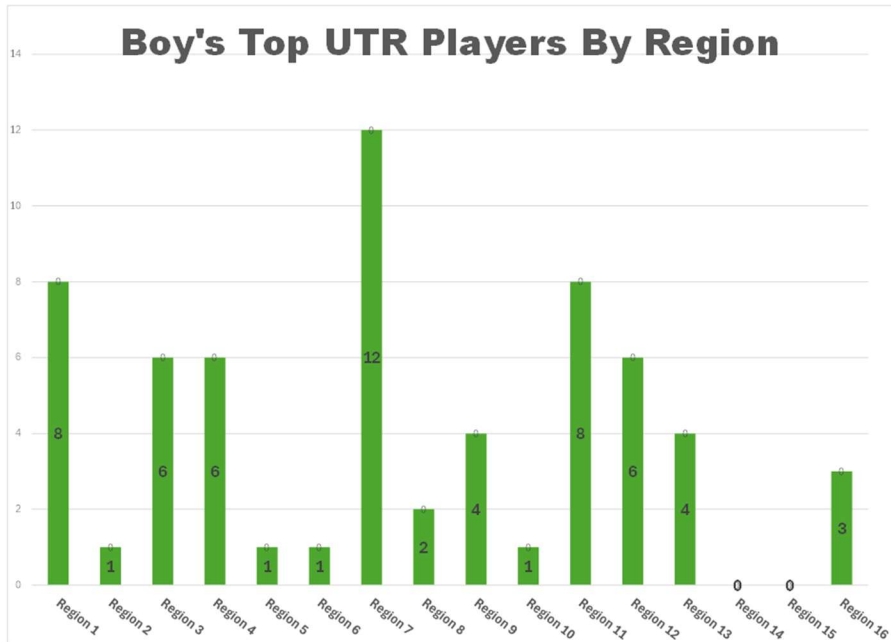
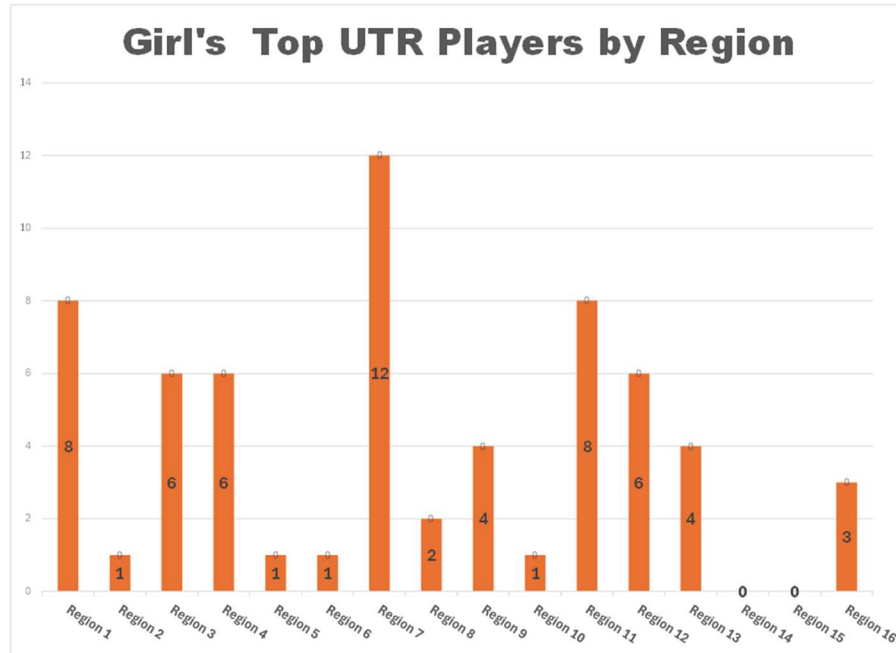

# Schools Completing Survey by Region





## What is your greatest concern(s) about having the new First Round played at four satellite venues? (119 responses)

- **Equity and Competition:** The grouping of strong regions (especially 5-8 and 9-12) will lead to highly-qualified players eliminating each other early, making the final 16 less representative of the state's best talent and disadvantaging players from those stronger regions. Conversely, players from weaker regions may advance more easily.
- **Diminished State Tournament Experience:** Many responders expressed concern that not playing the first round in Lexington takes away the "luster" and "reward" of qualifying for the state tournament, depriving most players of the full state experience and potentially impacting their motivation and scholarship opportunities.
- **Travel and Logistics:** Concerns include increased travel, associated costs (accommodation, food), supervision challenges for coaches managing split sites, and logistics regarding who will manage and run the first-round tournaments (seeding, draw, site rotation).
- **Venue Quality and Availability:** Concerns exist about ensuring the four satellite venues are neutral, have the required number of courts (such as 8 courts mentioned for the Eastern part of the state), and that the facilities chosen are high quality, potentially at colleges or private facilities, not just high schools.

## Would you like to provide specific, detailed feedback to KYHSTCA regarding this proposal? (76 responses)

- **Opposition to the proposal:** Many respondents believe the proposed changes are unfair to players from traditionally strong regions, potentially eliminating high-level players early and negatively impacting the quality of the state tournament.
- **Facility Concerns and Alternative Sites:** Several responses suggest exploring alternative locations to Lexington (like Bowling Green or Louisville) or utilizing more local high school/private club courts in the Lexington area to address facility issues instead of changing the format.
- **Suggestions for Fairness and Seeding:** There were suggestions to maintain a holistic seeding approach after regional qualification, consider at-large invites for high-caliber players from strong regions who are eliminated early, or have a smaller draw (e.g., only region champions or a 32-player draw).
- **Logistical Concerns:** The proposed schedule creates logistical and financial difficulties for schools, especially those far from Western KY, that have individual qualifiers and a full team playing team events sequentially.

- **Impact on Athlete Experience:** Concern was expressed that limiting players' opportunity to reach Lexington diminishes the special experience of the State Tournament and could reduce interest in the sport, especially for rural or lower-income students.
