

**Consent Agenda Item (Action Item):** Consider/Approve Change Order#1 with Rising Sun Developing for the BLES School Gym Renovation

**Applicable State or Regulations:** 702 KAR 4:160-Capital Construction Process

**Fiscal/Budgetary Impact:** This change order is in the amount of #42,885.40

**History/Background:** Following Board approval and KDE authorization of change orders to the cost of a project. The original BG-1 for the Betsy Layne ES Gymnasium Renovations on June 23, 2025 for \$3,516,568.57. The revised BG-1 in the amount of \$3,516,558.57 was approved on December 15<sup>th</sup>.

The change order does not include changes in the contract sum, contract time or guaranteed maximum price. The change order is now necessary to due asbestos abatement of approximately 175 TSI pipe elbows from all the hydronic piping that is set to be replaced during this renovation.

**Recommended Action:** To approve Change Order #1 as presented.



If Client desires us to restore the property to its former condition, we will accomplish this and add the cost to our fee.

DAMAGE TO EXISTING MAN-MADE OBJECTS - It shall be the responsibility of client or his duly authorized representative to disclose the presence and accurate location of all hidden or obscure man-made objects relative to our work and notify the Kentucky Underwriter "Before U Dig". AMD field personnel are trained to recognize clearly identifiable stakes or markings in the field, and without special written instructions, to initiate work within a reasonable distance of each designated location. If AMD is cautioned, advised or given data in writing that reveal the presence or potential presence of underground or overground obstructions, such as utilities, AMD will give special instructions to its field personnel. As evidenced by client's acceptance of this proposal, Client agrees to indemnify and save harmless AMD from all claims, suits, losses, personal injuries, death and property liability resulting from unusual subsurface conditions or damages to subsurface structures, owned by Client or third parties, occurring in the performance of the proposed services, whose presence and exact locations were not revealed to AMD in writing, and to reimburse AMD for expenses in connection with any such claims or suits, including reasonable attorney's fees.

SAFETY - Client agrees that, in accordance with generally accepted construction practices, the contractor will be solely and completely responsible for working conditions on the job site, including safety of all persons and property during the performance of the work, and compliance with OSHA regulations, including preparation of a site safety and health plan where applicable, and that these requirements will apply continuously and not be limited to normal working hours.
