

Memorandum of Understanding

Between

**Relationships, Education, Advancement, and Development for Youth (READY4Life)
Program**

Purpose:

This Memorandum of Understanding (MOU) establishes a collaborative relationship between Kentucky River Foothills Development Council's READY4Life Program (hereafter referred to as "Foothills") and Powell County School District (hereafter referred to as "the District") to support the development of healthy relationships, parenting, job & career advancement and financial literacy among high school students grades 9-12.

Facilitator and Case Manager (hereafter referred to as "FC, CM") will be responsible for guiding students through a structured program to ensure they understand the importance of healthy relationships, budgeting skills, and credit management for future financial stability.

Responsibilities of Foothills Relationships, Education, Advancement, and Development for Youth (READY4Life) Program:

1. Provision of Facilitator (FC) and Case Manager (CM):

- Assign a qualified FC to engage high school students within the District.
- Ensure the FC and CM receive the necessary training and resources to effectively support students in healthy relationships, parenting, job & career advancement, and financial literacy.

2. Program Implementation and Management:

- Oversee the implementation of the Ready For Life program within the District.
- Conduct required set-hour workshops per funding source.
- Provide incentives to students who complete all hours of the workshops, including all required pre- and post-assessments, per specific grant funding source participation completion.

Responsibilities of Powell County School District:

1. Provision of Facilities:

- Allocate appropriate space within the school(s) for the FC to conduct healthy relationships, parenting, job & career advancement, and financial literacy activities.
- Ensure the provided space fosters student engagement.

2. **Access to Students:**
 - Facilitate interaction between the Facilitator and high school students.
3. **Support and Collaboration:**
 - Collaborate with the FC on interactive activities.
 - Work with the CM to support students in developing future plans after graduation.

Joint Responsibilities:

1. **Communication and Coordination:**
 - Maintain regular communication between Foothills and the District to ensure program alignment and address any challenges promptly.
 - Coordinate efforts to integrate activities seamlessly into students' educational experiences.
2. **Data Sharing and Confidentiality:**
 - Share relevant student data and progress reports while complying with confidentiality and privacy regulations.
 - Use collected data to assess the impact of the program on students' understanding of healthy relationships, parenting, job & career advancement, and financial literacy.

Duration and Termination:

Term and Modification

This agreement shall take effect as of the READY4Life grant period and remain in force until the completion of the grant program (09/30/2025 to 09/29/2030).

Any amendments or cancellations to this MOU must be provided in writing with at least thirty (30) days' prior written notice.
