Applicable State or Regulations: KRS 160.470 (6)(a); BOE policy 04.1

Fiscal/Budgetary Impact: Report Only

History/Background: The attached FY 2027 Draft Budget complies with KRS 160.470 (6)(a) in that it contains the detailed, line item of estimated revenues and expenditures for the upcoming 2027 Fiscal Year. There are no proposed reductions or increases in this budget, it is a rollup budget only of the current FY 26 budget. **Fund 2, the special revenue fund, which includes ALL federal, state, and local grants, is NOT included as part of the draft budget.** All other fund's revenues and expenses that have budgeted in the 2026 Final Working Budget have been rolled up into the 2027 Draft Budget, meaning it contains the same amounts in Expenditure and Revenue codes with the exception of Fund 310 and 320 which changed due to SFCC cash requirement for the Betsy Layne Dome project and fund 21 which changes monthly with sweep account funds the schools submit. **Overall Budget reduction is a result of fund two not being included per KDE guidelines for the Draft Budget.** The Tentative Working Budget in May will have the updated, known information.

Recommended Action: Acknowledge receipt and public review of the 2027 Draft Budget.
