

SIXTH ADDENDUM TO
MEMORANDUM OF UNDERSTANDING

This sixth addendum to the Memorandum of Understanding dated January 10, 2022, entered into the ____ day of _____, 2026, by and between TODD COUNTY BOARD OF EDUCATION (hereinafter called “District”) and the TODD COUNTY SHERIFF (hereinafter called “Sheriff”);

WITNESSETH:

Whereas, the District and the Sheriff entered into a Memorandum of Understanding dated January 10, 2022; and,

Whereas, the District and the Sheriff entered into a First Addendum to that Memorandum of Understanding dated the 12th day of September, 2022;

Whereas, the District and the Sheriff entered into a Second Addendum to that Memorandum of Understanding dated the 13th day of March, 2023;

Whereas, the District and the Sheriff entered into a Third Addendum to that Memorandum of Understanding dated the 16th day of October, 2023;

Whereas, the District and the Sheriff entered into a Fourth Addendum to that Memorandum of Understanding dated the 8th day of January, 2024;

Whereas, the District and the Sheriff entered into a Fifth Addendum to that Memorandum of Understanding dated the 10th day of January, 2025;

Whereas, it is the desire of the Sheriff and the District to extend the term of this agreement and to memorialize the current total annual compensation of the school resource officers assigned to North Todd Elementary School, South Todd Elementary School, and Todd County Central High School.

NOW, THEREFORE, it should be and is hereby agreed as follows:

1. The term of this agreement shall be extended commencing January 1, 2026, and concluding December 31, 2026.

2. The District shall reimburse the Sheriff annually for salary, benefits, and retirement as follows:

Chris Driskill	\$63,375.41	100% of salary
John (Ed) Higgins	\$54,029.96	100% of salary
Rodney Moberly	\$38,053.83	75% of salary

3. In each and every other respect, the Memorandum of Understanding dated January 10, 2022, as modified by First Addendum, dated the September 12, 2022, as modified by Second Addendum, dated March 13, 2023, as modified by Third Addendum, dated October 16, 2023; as modified by Fourth Addendum, dated January 8, 2024; and as modified by Fifth Addendum, dated February 10, 2025, remains in full force and effect and its terms are incorporated herein by reference as except as modified herein.


