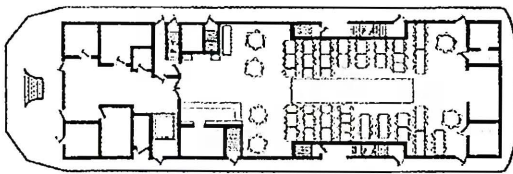

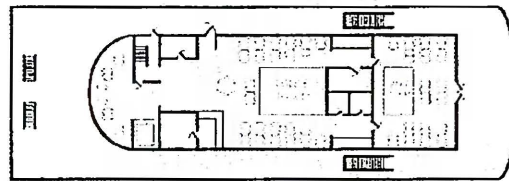

Newport Deck

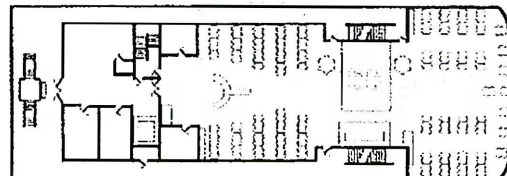


Bellevue Forward
