## Previous Year's Strategies Evaluation

*What strategies from last year went well?*

All Infrastructure and technical projects have gone well. Our Technical DLC has done a great job with training and implementation in classrooms and PLC's. Our new Instructional DLC has also done a great job in navigating the new position and reaching teachers with instructional technology skills and strategies, AI guidance, and KY academic standards.

*Needs that emerged after evaluation of the previous year's strategies?*

We will be refreshing all network devices (wired and wireless) pending funding request approval from USAC through the E-Rate program. With state funding/management of Active Directory going away, we plan to refresh our virtual environment, including creating our own instance of Active Directory, and implement a new backup strategy with offsite backups.

*How did you and the planning team decide on the strategies and/or adjustments for this plan?*

The work was divided into areas in which each contributor was an owner. Each contributor completed their own section and submitted to the CIO to compile and finalize.

*Briefly discuss the major activities slated for implementation and how these activities will advance curriculum and instruction integration, student technology literacy, professional development, & technology infrastructure.*

We are hoping to utilize new technical tools to improve processes and help with instruction. We are also looking into different options to move forward with our datacenter operations and network management, including cabling projects. We have a WAN contract that started 3 years ago with Spectrum lit fiber, which gives us more flexibility and lower risk. We have multiple security initiatives to make students and staff feel safer and more secure, including cybersecurity, physical security, and emotional and mental well-being. Our network device refresh will vastly improve our technology infrastructure, and along with almost all schools being re-cabled recently with Cat6 cabling, students and staff will have a much better experience with device dependability and network speed and stability. Our Digital Learning Coaches are working with schools to develop new and innovative ways to educate students on digital literacy. We also have multiple construction projects in progress that will continue for the next few years.
