Recommendation/Motion: Approve the revised BG-1 Project Application for the (1) Replacement of the Roof and (2) Replacement of Artificial Turf and Resurfacing of Track at Paul Laurence Dunbar High School, based upon bids received for both projects, in the amount of \$9,075,300.00 (Nine Million, Seventy-five Thousand, Three Hundred Dollars.)

Background/Rationale: The 2025 District Facility plan (DFP) includes replacement of the roof as item 1c.(1)1.1 and the replacement of the artificial turf field and resurfacing of the track item 5(4)4.3 at Paul Laurence Dunbar High School. These projects include: (1) replacement of entire roofing system and adding insulation to improve energy efficiency, and (2) due to normal life cycle and wear-and-tear, the artificial turf field and track are coming to the end of their expected life cycle and are ready for replacement.

A revised BG-1 Project Application for the construction, identifying the extent and cost of the work, was approved by the Board on February 23, 2026, meeting based on increase of the cost opinions. Clotfelter Samokar Architects produced Construction Documents for bidding describing these modifications for both projects. Based upon the bids for both projects, which have been approved simultaneously herein, a revised BG-1 Project Application is required as follows:
