HISTORY/BACKGROUND:

The Kenton County Board of Education approved the initial BG-1 application for the River Ridge Elementary Site Expansion Plan (BG #24-173) during the regular Board Meeting held on December 4, 2023, then approved a revised post-bid BG-1 at the February 2, 2026. The BG-1 has been revised to accurately account for all associated costs outside of the \$3,919,000.00 contract with Ashley Builders Group.

FISCAL/BUDGETARY IMPACT:

\$4,850,332.00 total project cost with \$3,919,000.00 being the total construction cost (\$4,850,332.00 from FSPK bond sale, \$577,730.00 from building fund cash reserves)
