**AMENDMENT TO THE AGREEMENT BETWEEN INDEPENDENT ELECTRICAL
CONTRACTORS OF KENTUCKIANA
AND JEFFERSON COUNTY BOARD OF EDUCATION**

THIS AMENDMENT TO THE AGREEMENT BETWEEN SPALDING UNIVERSITY AND JEFFERSON COUNTY BOARD OF EDUCATION (hereinafter "Amendment") is entered by and between the Jefferson County Board of Education, a political subdivision of the Commonwealth of Kentucky doing business as the Jefferson County Public Schools (hereinafter "JCPS"), and Independent Electrical Contractors of Kentuckiana ("IEC").

WHEREAS, The Parties have entered into an Agreement between JCPS and IEC effective April 1, 2026 to a Pre-Apprenticeship Program at IEC for students in JCPS Electrical Pathways (the "Agreement"); and

WHEREAS, The Parties wish to increase the funding available under the Agreement by \$1,420.

THEREFORE, the Parties wish to amend the Agreement.

This Amendment hereby amends the Agreement to alter paragraph 1.a. by removing the amount of \$20,020 and replacing it with \$21,440.

All other provisions of the Agreement shall remain unchanged. This Amendment is the entire agreement of the parties regarding modifications of the Agreement provided herein, supersedes all prior agreements and understandings regarding such subject matter, may be modified only by a writing executed by the parties. The Agreement is ratified and confirmed in full force and effect in accordance with its terms, as amended hereby. In the event of any conflict between the terms of the Agreement and this Amendment, the provisions of this Amendment shall control.

IN WITNESS WHEREOF, the parties hereto have executed this Amendment to be effective as of May 13, 2026.

- Recommendation: Superintendent Brian Yearwood recommends the Board of Education approve the attached Memorandum of Agreement with Independent Electrical Contractors of Kentuckiana for Pre-Apprenticeship Training and authorize the superintendent to sign the same.
- Rationale: This Agreement outlines a partnership with the Independent Electrical Contractors of Kentuckiana (IEC) to establish a Pre-Apprenticeship Program for high school students, supported by a \$25,000 commitment from T.E.M. Group, Inc. via the MSD Community Benefits Program.
- This agreement is established to strengthen career pathway opportunities for students enrolled in electrical programs by providing access to authentic, industry-based learning experiences. Through this partnership, students will have the opportunity to gain practical, hands-on experience hours within the electrical industry, allowing them to apply classroom knowledge in real-world settings. These experiences support the development of technical skills, workplace readiness, and professional expectations that are essential for success in high-demand skilled trades.

MEMORANDUM OF AGREEMENT
Between
Jefferson County Board of Education
And
Independent Electrical Contractors of Kentuckiana

This Memorandum of Agreement (hereinafter "Agreement") is entered into between the Jefferson County Board of Education (hereinafter "JCPS"), a political subdivision of the Commonwealth of Kentucky, with its principal place of business at 3332 Newburg Road, Louisville, Kentucky 40218 and Independent Electrical Contractors of Kentuckiana (hereinafter "IEC"), a 501(c)(3) trade school located at 1810 Plantside Drive, Louisville, KY 40299

WHEREAS JCPS has received a \$25,000 commitment from T.E.M. Group, Inc. through the MSD Community Benefits Program to provide job shadowing (hereinafter "Pre-Apprenticeship Program") to JCPS high school students enrolled in an electrical or related pathway; and

WHEREAS IEC is the premier trade school in the Jefferson County area providing educational services for electrical apprentices and contractors; and

WHEREAS JCPS and IEC desire to enter into an agreement to provide a Pre-Apprenticeship Program at IEC for 12-30 students in Electrical Pathways in JCPS High Schools to learn more about electrical apprenticeships as a career opportunity.

THEREFORE, in consideration of the terms, conditions, premises, and mutual agreements set forth herein, JCPS and IEC agree as follows:

1. Duties of JCPS:

- a. JCPS will support IEC to implement the Pre-Apprenticeship Program by:
 - i. Making a payment of \$20,020 to IEC to cover program costs.
 - ii. Identifying between 12-30 students enrolled in electrical or related pathways at JCPS High Schools to participate in the IEC program. Participating students will complete an Educational Enhancement Form prior to April 3, 2026.
 - iii. Providing bus transportation for 12-30 students for up to four (4) Pre-Apprenticeship Program sessions scheduled during regular school days in April-May 2026 (dates TBD) as needed.

2. Duties of IEC:

- a. Host a Pre-Apprenticeship Program in April-May 2026 at IEC's facility as follows:

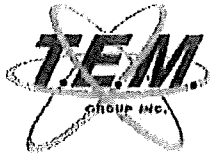
- i. Facilitate multiple sessions that may include evenings, Saturdays, and up to four (4) sessions during the regular school day. IEC will notify JCPS of any planned school-day sessions in ample time for JCPS to arrange bus transportation for participating students.
 - ii. Provide real-world job shadowing and corresponding instruction on careers in the electrical trade, professional behavior and study skills, safety, basic electrical concepts and theory, wiring, green energy, and job searches.
 - iii. Provide students with a meal for each session and all necessary tools and supplies to complete all Pre-Apprenticeship Program activities.
 - iv. Provide students with a swag bag (branded t-shirt, etc.)
- b. Acknowledges that projects involving program evaluation, monitoring activities, or data collection or research of any kind, are subject to JCPS IRB review and approval as determined by the JCPS IRB to meet federal, State, and Board policies. In these cases, JCPS student or staff participation is voluntary. As a federally authorized Institutional Review Board (IRB), JCPS complies with the federal definition for research, which includes sharing of Personally Identifiable Information (PII) for the purpose of answering a question or evaluating activities for effectiveness beyond standard educational or operational procedures. Thus, all research, program evaluation and data collection activities must be approved by the JCPS IRB and shall not begin before approval is secured from the JCPS IRB.
- c. If the performance of this Agreement involves the transfer by JCPS to IEC of any data regarding any student that is subject to the Family Educational Rights and Privacy Act of 1974, 20 U.S.C. 1232g as amended, ("FERPA"), IEC and JCPS must manage the data transfer in accordance with FERPA requirements, and IEC agrees to the following conditions:
 - i. If IEC requests transfer of identifiable data by JCPS that is subject to JCPS IRB procedures, as determined by the JCPS IRB to meet federal, State, and Board policies, JCPS cannot transfer identifiable data to IEC before the JCPS IRB-approved informed consent process has been executed. In this case, IEC does not function as an exception under FERPA. IEC is responsible for obtaining, and maintaining, signed consent after JCPS IRB approval. No data will be provided under this agreement without signed consent from the guardian for records requests involving students or from the JCPS employee or community member for records requests involving adults. IEC must deliver copies of the signed authorization to JCPS upon request.
 - ii. If IEC has been legally deemed a FERPA exception by JCPS in accordance with FERPA Exception Conditions, then IEC shall:

- (a) In all respects, comply with the provisions of FERPA, including any requirements of Chapter 99 of Title 34 of the Code of Federal Regulations and any other applicable state or federal law.
 - (b) Use any such data for no purpose other than to fulfill the purposes of this Agreement, and not share any such data with any person or entity other than IEC and its employees, contractors, volunteers, and agents, without prior approval of JCPS. Disclosure shall be limited to only those employees, contractors, volunteers, or agents who are necessary for the fulfillment of this Agreement.
 - (c) Require all employees, contractors, volunteers, and agents of IEC to comply with all applicable provisions of FERPA with respect to any such data. IEC shall require and maintain confidentiality Agreements with each employee, contractor, volunteer, or agent with access to data pursuant to this Agreement.
 - (d) Maintain any such data in a secure environment, whether physical or electronic, and not copy, reproduce, or transmit any such data except as necessary to fulfill the purposes of this Agreement. IEC shall notify JCPS within 24 hours in the event of any data breach or disclosure of data to any person or entity other than the parties listed in this agreement.
 - (e) Collect, store, and maintain data in a manner that does not permit the identification of an individual student by anyone other than employees, contractors, or agents of IEC necessary for the fulfillment of this Agreement and having a legitimate interest related to the purposes of this Agreement in knowing such personal identification, and not disclose any such data in a manner that would permit the identification of an individual student in any form, including, but not limited to, published results of studies.
- d. Use reports produced for this project only for the purposes described above. The data and reporting shall not be used for personal or institutional gain or profit.
 - e. To direct all communication and decisions regarding the evaluation, data collection, and analysis to the Accountability, Research, and Systems Improvement office.
 - f. Acknowledges that JCPS retains the right to audit IEC's compliance with this agreement.
 - g. IEC acknowledges that any violation of this Agreement and/or the provisions of FERPA or accompanying regulations related to the nondisclosure of protected student information constitutes just cause for JCPS to immediately terminate this Agreement pursuant to Article V of this Agreement.

- h. Not use the name or logo of JCPS or individual JCPS schools in printed materials, websites, videos or social media without prior approval from JCPS.
- i. Maintain an all-risk property and casualty insurance policy with respect to the facilities and a policy of commercial general liability in amounts no less than \$1,000,000/\$2,000,000 per policy and provide JCPS with a certificate of insurance upon request.
- j. Require all IEC employees/volunteers/contractors performing services under this Agreement to have on file a Criminal Records Check, per Kentucky law and JCPS requirements, completed no more than five years ago. Employees/contractors convicted of any of the following, per JCPS Board Policy 03.6, shall not be considered:
 - i. Any conviction for sex-related offenses.
 - ii. Any conviction for offenses against minors.
 - iii. Any conviction for felony offenses, except as provided below.
 - iv. Any conviction for deadly weapon-related offenses.
 - v. Any conviction for drug-related offenses, including felony drug offenses, within the past seven years.
 - vi. Any conviction for violent, abusive, threatening or harassment related offenses.
 - vii. Other convictions determined by the Superintendent/designee to bear a reasonable relationship to the ability to perform services under this Agreement.
- k. IEC shall require all staff and volunteers performing services on JCPS school premises during JCPS school hours under this Agreement to submit per KRS 160.380 to a national and state criminal history background check by the Department of Kentucky State Police and the Federal Bureau of Investigation and have a letter, provided by the individual, from The Cabinet for Health and Family Services stating no findings of substantiated child abuse and neglect records maintained by the Cabinet for Health and Family Services.
- l. IEC staff and volunteers will comply with all JCPS health safety guidelines including rules related to COVID-19 mitigation.
- m. To the extent that JCPS facilities are closed to students, those facilities will also be unavailable to IEC. During any periods of the Non-Traditional Instruction (NTI) or remote learning, JCPS facilities will not be available to IEC.

3. Mutual Duties:

- a. Each party shall not discriminate based on race, color, national origin, age, religion, marital or parental status, political affiliations or beliefs, sex, sexual orientation, gender identity, gender expression, veteran status, genetic information, disability, or limitations related to pregnancy, childbirth, or related medical conditions.
 - b. Each party shall comply with all federal and state laws and regulations and all JCPS policies applicable to the provision of the services described in this Agreement, including without limitation the Federal Family Educational Rights and Privacy Act (FERPA), the Kentucky Educational Rights and Privacy Act (KFERPA), the federal Health Insurance Portability and Accountability Act (HIPAA) and JCPS policies and procedures for volunteers and visitors entering JCPS facilities.
 - c. The respective administrative offices of JCPS and IEC who have responsibility for the implementation of this Agreement shall meet periodically during the term of this Agreement to evaluate the program and discuss issues of mutual concern.
4. **Term:** This Agreement shall be effective commencing April 1, 2026 and shall terminate on December 31, 2026. The Agreement may be extended by mutual written agreement of JCPS and IEC.
5. **Termination:** Either party may terminate this Agreement prior to the end of its term by giving sixty (60) days prior written notice to the other party. If JCPS terminates the Agreement, IEC will be permitted in their discretion to continue to provide services during the period in which the sixty (60) day notice becomes effective. JCPS may terminate this agreement immediately in the event of a student health or safety concern or a breach of paragraph 2.j above. In the event of an immediate termination, IEC shall not be permitted to continue to provide services after receipt of the notice of termination.
6. **Amendment:** This Agreement may be modified or amended only by a written agreement signed by JCPS and IEC.
7. **Independent Parties:** JCPS and IEC are independent parties, and neither shall be construed to be an agent or representative of the other, and therefore neither shall be liable for the acts or omissions of the other. Each party shall, however, be liable for any negligent or wrongful acts of its own employees, students and invitees.
8. **Captions:** Section titles or captions in this Agreement are inserted as a matter of convenience and reference, and in no way define, limit, extend, or describe the scope of this Agreement.
9. **Entire Agreement:** This Agreement contains the entire agreement between JCPS and IEC concerning the Pre-Apprenticeship Program and supersedes all prior agreements, either written or oral, regarding the same subject matter.



12. **Applicable Law:** This Agreement shall be governed by, and construed in accordance with, the laws of the Commonwealth of Kentucky.

Recommended Motion

Superintendent Brian Yearwood recommends the Board of Education approve the attached Amendment to a Memorandum of Agreement with Independent Electrical Contractors of Kentuckiana ("IEC") and authorize the Superintendent to sign the same.

Rationale

Jefferson County Public Schools (JCPS) is amending its agreement to pay IEC \$20,020 to offer pre-apprenticeship training to high school students in Electrical Pathways. JCPS transportation costs were less than planned and the district will increase IEC's payment by \$1,420 to \$21,440 to enhance the program.
