

## **MEMORANDUM OF AGREEMENT**

### **Between Hopkins County Central High School Golf Teams (girls and boys) And Madisonville Country Club**

**This Memorandum of Agreement (MOA)** is made and entered into this \_\_\_ day of \_\_\_\_\_, 2026, by and between **Hopkins County Central High School**, hereinafter referred to as “HCCHS,” and **Madisonville Country Club**, located at, hereinafter referred to as “MCC.”

#### **Purpose**

The purpose of this MOA is to establish the terms and conditions under which the Hopkins County Central High School golf teams (boys and girls) will be allowed to use the facilities of Madisonville Country Club for practices and matches during the high school golf season.

#### **Terms and Conditions**

##### **1. Facility Use**

MCC agrees to allow HCCHS golf teams access to the golf course, driving range, and practice greens for scheduled practices and matches during the designated KHSAA golf season.

##### **2. Schedule**

- HCCHS will coordinate with MCC staff in advance to schedule practice times and home match dates no less than 7 days in advance. This includes all practices, practices rounds and matches/tournaments.
- MCC will make reasonable accommodations based on course availability.
- Madisonville North Hopkins High School golf teams may contact the MCC staff to see availability for the usage of the course and/or facilities 5 days in advance when HCCHS golf team is not utilizing the course. On days that HCCHS is NOT using the course, MNHHS may request the use of the MCC facilities with the same terms and conditions as HCCHS. All events shall be scheduled in Eventlink for HCPS. MNHHS administration and coaches will have access to the schedule to determine availability.

##### **3. Supervision & Conduct**

- All HCCHS golf team practices and matches shall be supervised by a school-appointed coach or staff member.

- Students will be expected to follow all MCC rules, dress codes, and standards of conduct while on MCC premises.

**4. Liability and Insurance**

- HCCHS will maintain appropriate liability insurance coverage for its students and staff while on MCC property.
- MCC will not be held liable for injuries or accidents occurring during practices or matches, except in cases of proven negligence on the part of MCC.

**5. Fees**

- The Hopkins County Board of Education will pay MCC a fee of \$2,500.00 annually for the use of the course and its facilities during this time to include range balls.

**6. Golf Carts**

- The use of golf carts for practices will not be allowed unless authorized by the MCC staff.
- In the event that carts are used, the school shall be responsible for the costs.
- Drivers of the cart must be at least 16 years of age.

**7. Duration of Agreement**

This agreement will be effective from July 10 2026, and will remain in effect through the conclusion of the 2026 high school golf season, unless terminated earlier by either party with written notice of at least 30 days.

**8. Amendment & Renewal**

This MOA may be amended in writing by mutual consent of both parties. Renewal discussions for future seasons will occur prior to the start of the next golf season.
