This agreement outlines the renewal of the Imagine Learning platform (formerly Edgenuity) for the Bullitt County Public Schools district for the 2026-2027 school year. The contract provides a comprehensive suite of digital curriculum and support services across the district's middle schools, high schools, and specialized centers. Key services will include the upgraded platform EdgeEX, specialized suites for exceptional students, and enhanced CTE (Career and Technical Education) licenses. The agreement also features integrated academic integrity tools and on-demand tutoring services at both the site and concurrent-user levels.

The total investment for this district-wide renewal is \$171,881.50 and will be paid out of Curriculum, Assessment and Instruction funds. This agreement has been reviewed by Dismore & Shohl, Inc. Approval is requested.
