Flooring	The flooring for the arena is now in the bidding process. The pricing is as follows: roll and tarp the floor is \$1250.00. To install the hard surface flooring is an additional \$2,000 for a total of \$3,250.00
Wall Opening	A section of the arena wall can be removed for access from the South Exhibit Hall. \$800.00
Steps	Steps to the arena floor can be installed. It is my understanding the event will not require this option. \$250.00 per set of steps
Suites per suite)	\$300.00 per suite 8 suites are available. The price reflects a 40% discount (normally \$500.00)
Expo 20% discount.	\$760.00 to \$2,400.00 per day (North Exhibit Hall) depending on sections. Price reflects a 20% discount.
Parking	Fee waived. Normally \$3.00 per vehicle per day or \$5.00 per vehicle per event.
