01.1 Legal Status of the Board

HISTORY/BACKGROUND:

In previous years the KCS D has leased school buses with drivers to the Beechwood Independent School District (BISD) to provide supplemental transportation for Beechwood's field trips and extra-curricular activities. BISD is requesting to continue these services through Kenton County Schools Transportation Department for the 2026-2027 school year.

FISCAL/BUDGETARY IMPACT:

Beechwood ISD will compensate KCS D per our current lease rates for scheduled trips.

Re: Memorandum of Understanding for Supplemental Transportation Services

The Beechwood Independent Board of Education, in an effort to provide student-related and extracurricular activities, requests a Memorandum of Understanding with the Kenton County Board of Education for transportation services.

The Beechwood Independent Board of Education requests the following as a memorandum of understanding with the Kenton County Board of Education:

1. The Kenton County Board of Education will annually recognize the Beechwood Independent Board of Education as an entity that can request supplemental transportation services from the Kenton County Transportation Department for student related and extra-curricular activities.
2. The Beechwood Independent Board of Education, and the employees there of, will abide by the transportation request procedures established by Kenton County Board of Education, and the Kenton County Transportation Department.
3. The Beechwood Independent Board of Education agrees to compensate the Kenton County Board of Education for transportation services provided at an agreed-upon rate structure and with an agreed-upon payment schedule.
4. The Beechwood Independent Board of Education will provide a Certificate of Liability insurance and other documentation requested by the Kenton County Board of Education in order to provide the requested services.
5. The Beechwood Independent Board of Education will promptly respond to any concerns brought forth by the Kenton County Board of Education, the Kenton County Transportation Department, or employees there, in order to maintain compliance with regulations related to student transportation.
6. The termination of this agreement, by either party can be initiated in writing within 30 days notice.
