B. Instructional Report

a. MCHS Leadership Team Marshall Male Conference Presentation

Toddie Adams introduced MCHS student Sophie Collins who talked about the Marshall Male Conference the Leadership Class at MCHS recently sponsored. Fellow Leadership student Mia McGregor then spoke to the board about the artwork she and fellow students designed that will be hung in the Marshall County Board Office.

b. Calvert City Elementary Principal Kendra Glenn - Family Friendly Certification Presentation

Calvert City Elementary Principal Kendra Glenn spoke to the board about the Familly Friendly certification the school recently received and she explained the motivation behind why the school decided to apply for the certification.

c. Cognia Accreditation Update - Jackie Reid

Instructional Supervisor Jackie Reid updated the board on the ongoing Cognia Accreditation process. She included a link to the presentation the district did for the Cognia reviewers and said the reviewers were highly complimentary of the things we are doing in the district. Reid says the district is currently waiting for the reviewer to put all of her information into a report, hopefully soon after Christmas. She expects to hear something final on the accreditation by mid-January.

C. Personnel Report

Amanda Henderson shared with the board the district's new tradition of awarding service pins to employees who have 5,10, 15, 20, 25, 30, and 30 plus years of service. Additionally, first year employees were awarded pins for completing their first year. The names of the 83 certified and 75 classified staff members scrolled on the screen as Henderson explained how the employees were presented their pins and certificates at their schools recently.

D. Attendance/Safety Report

Pupil Personnel Director Brent Lovett says attendance was down a little bit last month due to sickness with most schools reporting a drop of about half a percentage point from the previous month. Lovett says the district is still doing fairly well with Calvert City and South Marshall Elementaries coming in just a shade under 95%. Lovett says the district is getting back close to average for December.

Safety Report: Lovett says there was a Safety Committee meeting in November. The district has installed cell phone boosters at JES, SMMS and SES. And, Lovett says the district has added a way to report bullying on the "Let's Talk" communication tool accessible on the district's website.

E. Transportation/Facilities Report

Fuel Report: We purchased \$33,281.83 of Diesel fuel and \$2,937.88 in unleaded this month.

MCHS – Concession and trophy cases have been completed.

MCTC Project – The garage doors were installed in the shop areas. Trusses have been set on the storage building. The one concern we have is the block laying schedule. Their hope is for over break to make up some of that time.
