1. 09.2242 Policy

Effective January 1, 2025, this Policy shall either prohibit the use of medicinal cannabis on school property or permit the use of medicinal cannabis on school property by a pupil who is a registered qualified patient as deemed necessary by the pupil's parent or legal guardian. Must select one option: The Board prohibits the use of medicinal cannabis on school property by a pupil who is a registered qualified patient as deemed necessary by the pupil's parent or legal guardian as described above. If the Board enacts a policy to permit the use of medicinal cannabis by a pupil who is a registered qualified patient, that policy shall: Require medicinal cannabis be administered: a. i. By a school nurse or under the supervision of appropriate school staff; or ii. By the parent or legal guardian of the pupil who is a registered qualified patient; and b. Out of view of other students; and Include a process by which a school nurse or other school staff member may by written acknowledgement (09.2242 AP.2) refuse to administer or supervise the administration of medicinal cannabis.
