Attached is the staffing allocation formula developed in September for Trigg County Public Schools. The recommended staffing formula uses a multiplier to provide additional staff to the school for the purpose of Explore Teachers or Elective Teachers. This is the final staffing allocation based on enrollment numbers as of March 1, 2024, and has been reviewed with each of our principals. There has been no change from the February 8th draft to the total number of staff allocated to the schools. FY 25 Special Education Staffing: There will be an additional instructional assistant added to the Intermediate School and High School due to need and the Middle School will have a reduction of an Instructional Assistant otherwise no additions and no reductions in special education staffing for the FY 25 school year. The general rule is staffing is 80% of caseload for LBD and 85% caseload for SLP; however each school is staffed based upon the individual needs of the students.

With the legislative session ending, I recommend a salary schedule which provides a 5% increase to base salary for all staff. In the FY25 salary schedule we also request a slight change to the classified salary schedule which will provide a streamlined schedule.
