Grant Holbrook broke his own school record in the Boys 1 Mile Run with a time of 4:17.04 at the 2026 KY Dream Mile Race and later set a new school record in the 1600m Run with a time of 4:12.51 at the 2026 KHSAA Class 3A Region 5 Championship Meet. Holbrook, Jilesh Davis, Sam VandeWater, and Tharusha Dambadeniya also established a new school record in the Boys 4x1600m Relay with a time of

18:52.95.

At the 2026 KHSAA Class 3A Region 5 Championship Meet, Holbrook earned Regional Runner-Up honors with second-place finishes in both the 800m Run and 1600m Run. He continued his outstanding season at the KHSAA State Track & Field Championships, placing fifth in the 1600m Run.

Several Camels earned Northern Kentucky Track & Field Coaches Association (NKTFC) All-Region recognition for their performances during the 2026 season. First Team honors were awarded to Grant Holbrook (800m, 1600m, and 4x400m Relay). Second Team selections included Xavier Pretot (400m and 4x400m Relay), Sam VandeWater (3200m and 4x800m Relay), Grant Kloeker (Shot Put), Derek Verst (Pole Vault), Camden Gunn (4x400m Relay and 4x800m Relay), Mason Skirvin (4x400m Relay), Jilesh Davis (4x800m Relay), and Ronnie Peveler (4x800m Relay). Honorable Mention recognition was earned by Mason Skirvin (100m), Cameron Gobich (300m Hurdles), Grayson Kuhnhein (Discus), and Wesley Stanley (Pole Vault).

The Lady Camels Track & Field team captured both the 2026 NKAC Championship and the 2026 KHSAA Class 3A Region 5 Championship. The NKAC title marked the program's first conference championship since 2012, while the regional championship was the school's first since 2012. Team members included Leah Boggs, Adalynn Brackett, Mariah Burton, McKinna Butts, Brooklynn Cole, Micah Dawson, Lila Dunlevy, Isabella Evers, Meryem Gonulates, Rylie Hughes, Morgan Jakab, Mariah Koch, Emi Koroly, Chloe Kramer, Kayden Kramer, Allison McKee, Katherine McKee, Jordyn Mortimer, Emma Naylor, Brooklynn Phelps, Hailey Roomes, Kaylie Scales, Jessica Shoemaker, Allison Tiemeier, Kendall Wallace, and Alexia Yenter.

The Lady Camels also delivered an outstanding performance at the 2026 KHSAA Class 3A Region 5 Championship Meet. Regional champions included Mariah Burton in the 200m Dash and 400m Dash, Emma Naylor in Pole Vault, the 4x400m Relay team of Mariah Burton, Lila Dunlevy, Allison McKee, and Meryem Gonulates, and the 4x200m Relay team of Mariah Burton, Kaylie Scales, Kendall Wallace, and Hailey Roomes. Regional runner-up finishes were earned by Lila Dunlevy in the 800m Run and the 4x800m Relay team of Brooklynn Phelps, Katherine McKee, Allison McKee, and Lila Dunlevy. Kendall Wallace set a new school record in the Girls Long Jump with a leap of 15' 11".

At the KHSAA State Track & Field Championships held at the University of Kentucky on May 23, Emma Naylor placed fourth in Pole Vault, Leah Boggs placed fifth in Pole Vault, and the 4x200m Relay team of Mariah Burton, Kaylie Scales, Hailey Roomes, and Kendall Wallace placed fifth.

Several Lady Camels earned Northern Kentucky Track & Field Coaches Association (NKTFC) All-Region honors for their performances during the 2026 season. First Team recognition was awarded to Mariah Burton (200m, 400m, 4x200m Relay, and 4x400m Relay), Lila Dunlevy (800m, 4x400m Relay, and 4x800m Relay), Emma Naylor (Pole Vault), Kendall Wallace (4x200m Relay), Kaylie Scales (4x200m Relay), Hailey Roomes (4x200m Relay), Allison McKee (4x400m Relay and 4x800m Relay), Meryem Gonulates (4x400m Relay), Brooklynn Phelps (4x800m Relay), and Katherine McKee (4x800m Relay). Second Team honors went to Meryem Gonulates (300m Hurdles), Katherine McKee (3200m), Kendall Wallace (Triple Jump), Adalynn Brackett (High Jump), McKinna Butts (Shot Put), and Leah Boggs (Pole Vault). Honorable Mention recognition was earned by Kaylie Scales (200m), Kendall Wallace (Long Jump), Micah Dawson (Triple Jump), and Jordyn Mortimer (Shot Put).

Additional honors were earned by Allison Tiemeier, recipient of the 2026 NKTFC Female Athlete Scholarship, and Coach Toni McKee, who was named the 2026 NKTFC Girls Coach of the Year.

**Whereas**, Dr. Wilson completed renovations to the Middle School and construction of the new Grant's Lick Elementary School; and

**Whereas**, Dr. Wilson led the planning and funding for an innovative redesign of the Campbell County Middle School bringing new programming to the District and consolidating several facilities into one building; and

**Whereas**, through her recognition of the accomplishments of faculty, staff, and students, and strategic use of District funds to provide competitive salaries and benefits, Dr. Wilson created a strong, positive environment resulting in improvements in staff morale, retention, and recruitment of outstanding teachers; and
