Any expense required to satisfy this condition shall be paid by Mullins. Failure to comply with this condition will result in Mullins's certificate being administratively suspended until such condition is satisfied.

Mullins is aware that should she violate KRS 161.120 in the future, the Board shall initiate a new disciplinary action and seek additional sanctions.
